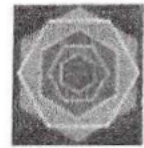

To Whom It May Concern,

This notice is submitted on behalf of the claimants due to the City's negligence, property mishandling, and unlawful conduct by Portland Police Bureau personnel.

Pursuant to Oregon Revised Statutes § 30.275, this letter provides formal notice of a tort claim against the City of Portland and its employees, including the Portland Police Bureau (PPB), in relation to events occurring on and after December 5, 2024. This claim is brought jointly by Deanna L. Drennen and her father, Vincent Drennen Jr., as both were directly harmed by the actions taken by PPB during and after the incident described below.

Date of Incident:

December 5, 2024 through present (continuing harm and misconduct)

Summary of Claims and Allegations:

On December 5, 2024, Ms. Drennen was arrested by Portland Police Bureau officers in connection with a disputed property retrieval involving a trailer she believed had been wrongfully taken. At the time of the arrest, she was in possession of a key belonging to her father's truck and a magazine clip. Body-worn camera footage clearly shows an officer negligently placing both items on the back of a police cruiser but only collecting the magazine clip. The key was never returned. The District Attorney later told Mr. Drennen that Ms. Drennen was lying and that no key was in her possession at the time of arrest. Which was later proven as a false claim after reviewing the police worn body camera footage.

The Portland Police towed Mr. Drennen's truck, later releasing it without the ignition key. The truck had to be towed again and the ignition forcibly altered, resulting in property damage and financial cost. During this time, while the truck remained under police control, the alleged victim was allowed to loiter near the vehicle and ultimately stole the trailer hitch. Despite officers observing this individual lingering around the truck, they failed to secure the scene or prevent the theft.

Body-worn camera footage revealed several disturbing behaviors by officers:

- Joking about using a police K9 on Mr. Agvinyan (Ms. Drennen's fiancé), despite him posing no threat.
- Making inappropriate comments about local residents and their concern for police presence.

- Laughing about damaging patrol vehicles while driving recklessly.
- One officer was seen covering her trainee's camera and advising her to stay still around the K9, stating the dog "forgets his target."

Ms. Drennen was denied access to a phone for nearly two full days while in custody. Meanwhile, the District Attorney contacted Mr. Drennen directly, discouraging him from posting bail, spreading misinformation about the missing key, and urging him to cut off his daughter's contact with Mr. Agvinyan.

Although Mr. Agvinyan accepted a plea deal that allegedly included the dismissal of charges against Ms. Drennen, she continues to face prosecution and remains under a no-contact order with him.

Additional Context and Prosecutorial Conduct:

Ms. Drennen, who has no criminal history, has been treated as a primary suspect despite a lack of evidence and clear prosecutorial bias. Her co-defendants had open legal issues, which appear to have been leveraged to extract guilty pleas. Ms. Drennen continues to maintain her innocence and is scheduled for trial on June 18, 2025.

Damages and Harm Incurred:

- Loss of property and damage to Vincent Drennen Jr.'s truck (ignition, towing, trailer hitch)
- Emotional distress and psychological harm
- Violation of constitutional rights (due process, access to legal counsel)
- Reputational harm and prosecutorial misconduct

Preservation of Rights:

This notice is filed in compliance with ORS 30.275 to preserve the right of both claimants to pursue legal action. We reserve the right to amend or supplement this notice as new information arises.
