SUBJECT: Lair Hill Diverters

I have been informed that the engineer's estimate for the Lair Hill Diverters is \$58,427 which exceeds the \$51,630 appropriated in the Bureau of Traffic Engineering HCD budget. Also, there might be additional Street and Structures costs which will increase the total project cost.

Although there is reluctance to go out to bid without sufficient appropriation to cover the engineer's estimate, we do not want to delay the project and request that you proceed with the bid process. As soon as the bids are in and we have a firm estimate of the total project cost, we will prepare an ordinance for council consideration to cover additional project costs over and above the budgeted \$51,630.

On Monday, November 10, 1980, the City's pilot test of the proposed Preferential Parking Permit Program will begin in the Lair Hill Neighborhood.

The residents of this neighborhood (bordered by S.W. Barbur, S.W. Arthur, S.W. Front, and S.W. Pennoyer) will be issued permit decals to be placed on their automobiles, which will allow them unrestricted time usage of curb parking. Non-resident, or non-permittee vehicles will be restricted by a two hour parking time limit in this area. Non-resident vehicles parking longer than two hours will be subject to a \$10.00 parking violation. These parking restrictions will be in effect Monday through Friday from 7:00 a.m. to 6:00 p.m.

Parking permits may be obtained by Lair Hill residents at the Neighborhood House (3030 S.W. 2nd Avenue) on November 3 and 4, 1980 from 9:00 a.m. to 4:00 p.m. For added convenience, these permits will also be issued on Monday evening, November 3, 1980 from 4:00 p.m. to 9:00 p.m. After November 4, 1980 permits will be issued from the Permit Center, Room #111 City Hall (1220 S.W. 4th). Additional information may be obtained from the Bureau of Traffic Engineering by calling 248-4295.

This program was one of two authorized by the City Council of September 4, 1980 to test the effectiveness of a permit program to alleviate congestion and safety problems caused by extensive on-street parking in residential areas. The other program, in the Gander Ridge area west of Portland State University, has been in effect since October 1, 1980.

Original estimates for the Lair Hill diverters ran \$51,630 for the total project. This included design and structural engineering and construction. A total of \$14,465 was expended on design and structural engineering last fiscal year. We had originally anticipated returning these appropriations during the first quarter allotment, however, construction estimates are running higher than anticipated. Dennis Tolls of BSSE, estimates these at \$47,000. Were we to return the \$14,465 as planned, we would not have sufficient appropriation to cover the construction phase. As such, we are requesting that you delete that transfer from the first quarter allotment ordinance. Should there be any excess appropriation for this project once it is contracted, we will return it during the second quarter allotment process.

1. Reduced speed limit (10 mph)
2. Children at play--slow
3. Reduce speed on the turns
4. 5 mph for apartment complex
5. school bus stops here

We request these signs to protect the 60 children now residing in our complex. The people who race up and down the street without regard to our children need to be made aware of the dangers here, before someone is critically injured by them.
