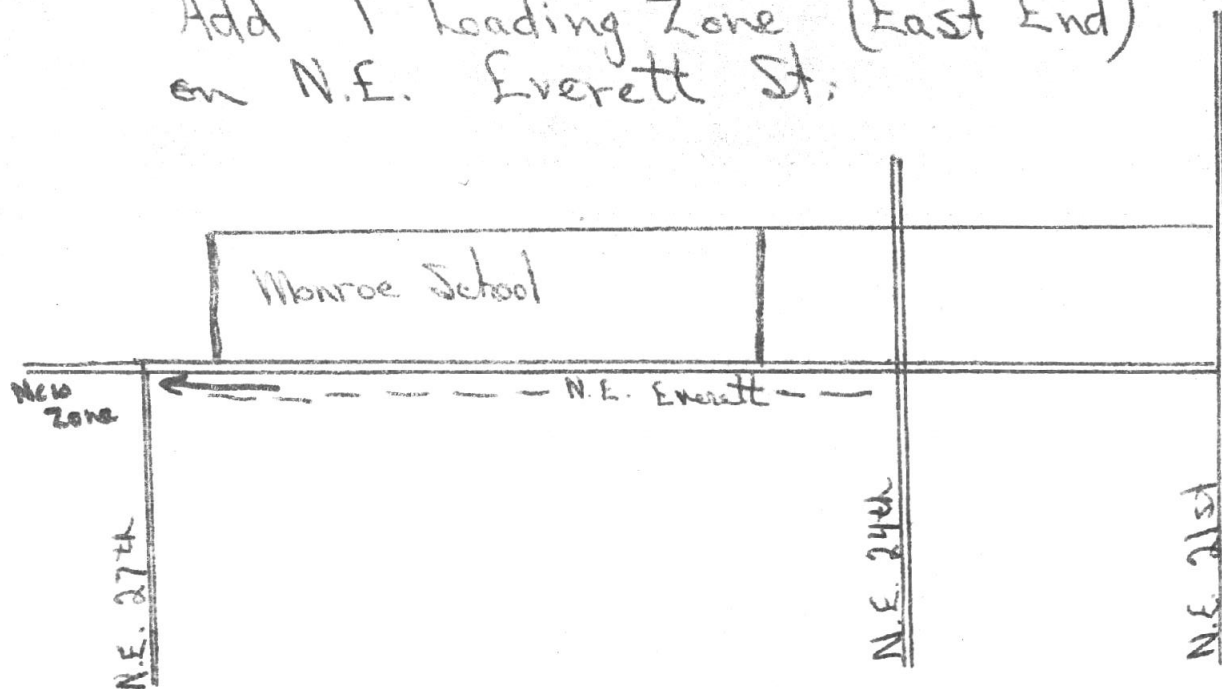

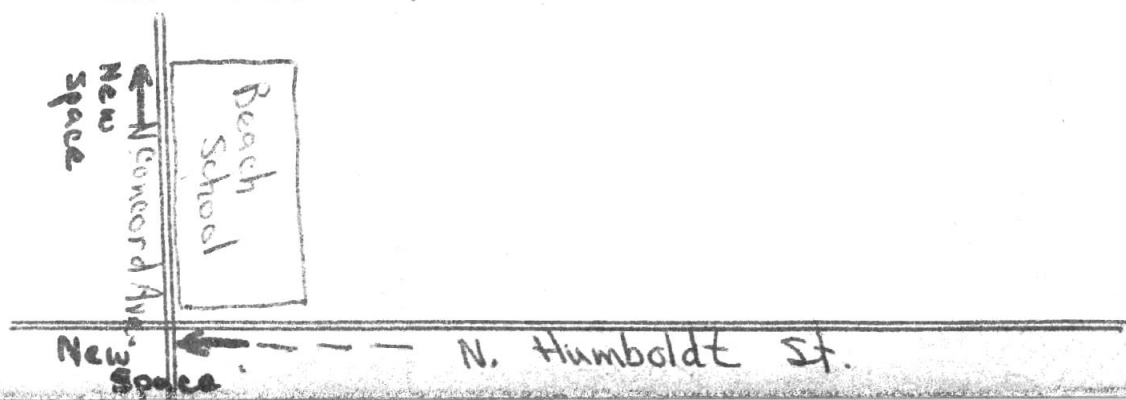

Beach School:

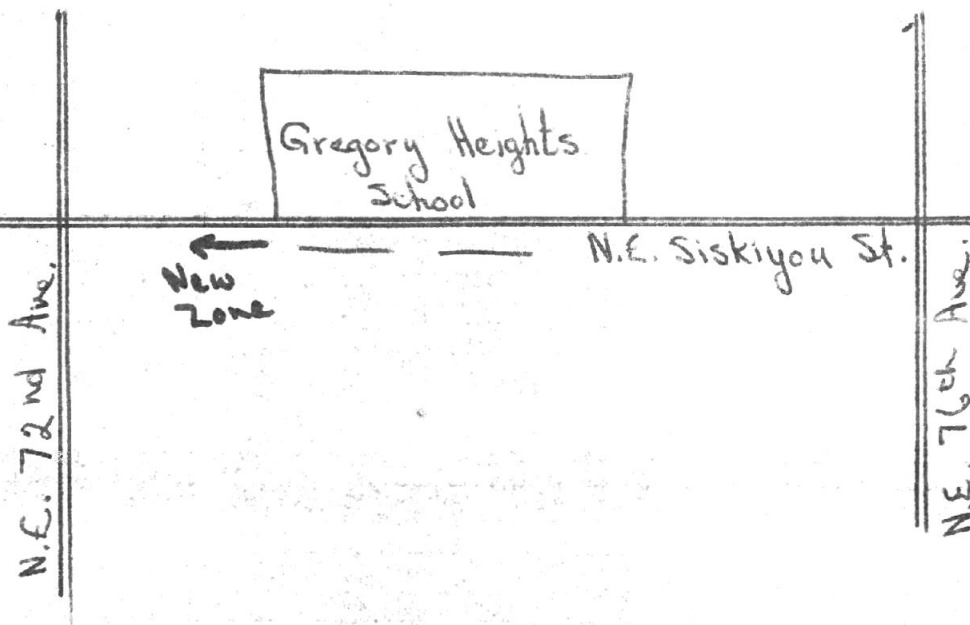
Add 1 Loading Zone (North of current spaces)

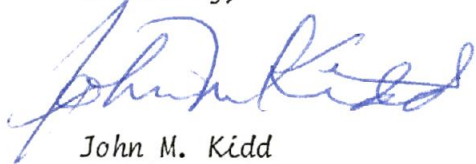

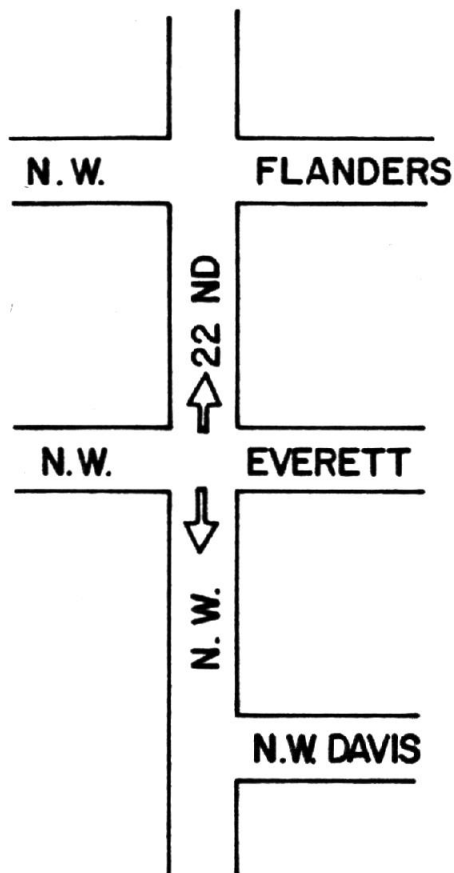

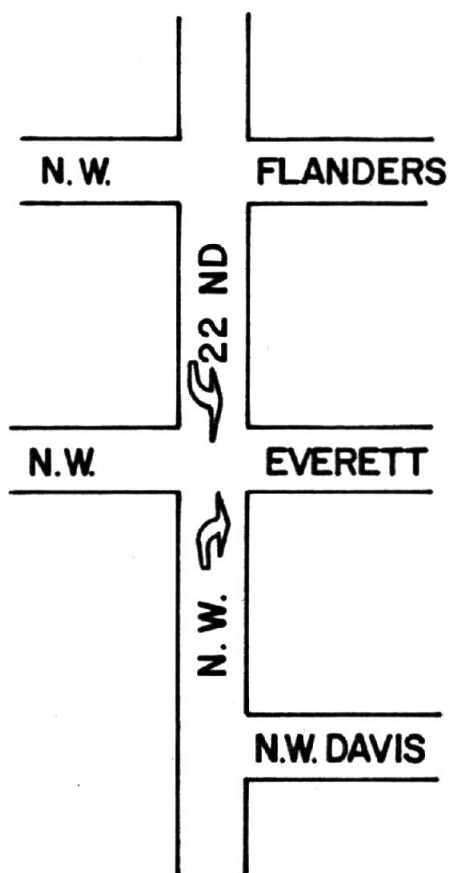
The vehicular accident situation at N.W. Everett St. and N.W. 22nd Ave. now demands special attention.

Other than an eastbound stop for one-way Everett, with a high preponderance of traffic entering the intersection compared to 22nd, there are several possible alternatives.

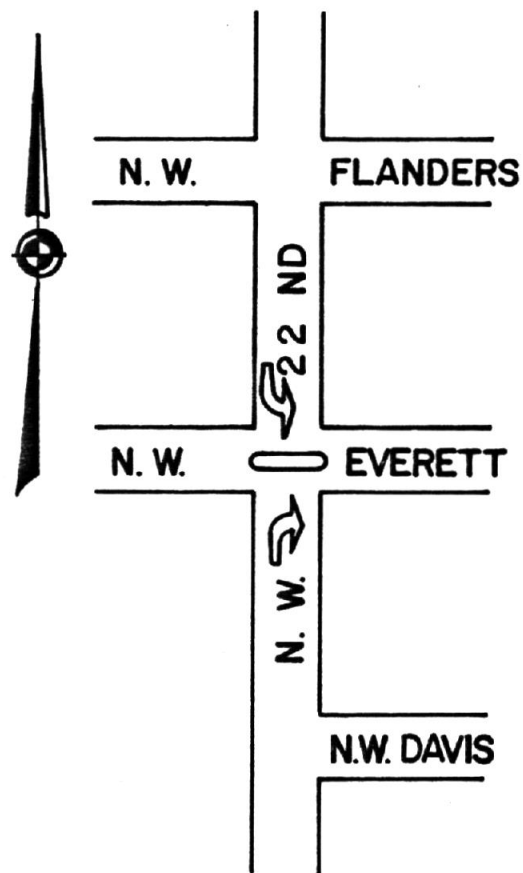
1. Convert 22nd to one-way southbound to Davis and one-way northbound to Flanders.
2. Require northbound 22nd to right turn at Everett and southbound to left turn.
3. In addition to (2), include a raised median in Everett to physically prevent straight movements from either direction on 22nd.
4. Block 22nd at the south side of Everett, making 22nd dead end north of Davis.
5. Block 22nd at the north side of Everett, making 22nd dead end south of Flanders.
6. Block 22nd at both the north and south sides of Everett.



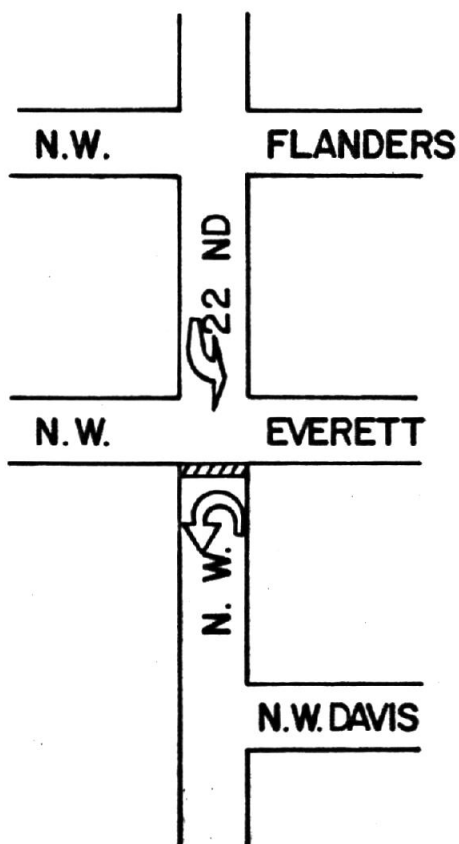

We would notify you of the decision and the trial period.
