The City Elections Office reviewed your Candidate Filing Application (AUD 120), confirmed payment of the appropriate filing fee, and certified that all requirements are met in accordance with applicable regulations. Multnomah County Elections certified that you are a registered voter in the City of Portland. According to available records, the residence address on your filing forms is located within the limits of the City of Portland, and you have resided within the City limits since at least November 5, 2023.
