APPEAL INFORMATION SHEET

Appeal item 1

Code Section	703.2 & 705.5
Requires	703.2 requires a tested fire assembly and 705.5 requires exterior walls with a fire separation distance of less than or equal to 10 feet are required to be rated for exposure to fire from both sides.
Code Modification or Alternate Requested	We propose an alternative assembly to provide the fire protection from the interior side of the wall only.
Proposed Design	We are proposing (2) layers of type X 5/8" GWB to be applied to the interior side of the existing 2 X 4 stud wall. As an alternative to one of the layer, fire rated sheathing is proposed to be an option. This detail will continue from the floor sheathing to the underside of the roof sheathing and no penetrations will be allowed.
	The FlamePro Fire retardant treated plywood has undergone the same tests as the type X GWB and carries the same UL rating (class A per ASTM E84).
	The wall is 8'10" from Property line.

Reason for alternative	This is an existing wall and demo'ing the exterior finishes would be cost prohibitive and waste of materials.
	Table 722.6.2 assigns a single layer of 5/8" type X gwb a 40 minute fire rating when installed over 2 X 4 at 16" oc wood studs. It is a logical conclusion that two layers of this over 2 X 4 studs at 24" oc will provide a

one hour fire rating when exposed to fire from either side.

Appeal item 2	
Code Section	703.2 & 708.4
Requires	703.2 requires a tested fire assembly and 708.4 requires that fire partition protection for the corridor must be continuous to the floor sheathing above or to the fire rated roof/ceiling assembly.
Code Modification or Alternate Requested	We propose an alternative assembly to provide the fire protection from one side of the ceiling only.
Proposed Design	We are proposing (2) layers of type X 5/8" GWB to be applied to the under side of the existing 2 X 4 rafters.
Reason for alternative	Table 722.6.2 assigns a single layer of 5/8" type X gwb a 40 minute fire rating when installed over 2 X 4 at 16" oc wood studs. It is a logical conclusion that two layers of this over 2 X 4 studs at 24" oc will provide a one hour fire rating when exposed to fire from either side.
	This will allow us to keep the attic space unaltered.

APPEAL DECISION

1. Alternate 2-hour wall assembly to provide fire protection from the interior side. only: Granted as proposed.

2. Alternate 1-hour roof / ceiling assembly with fire protection at the ceiling side only: Granted as proposed.

The Administrative Appeal Board finds that the information submitted by the appellant demonstrates that the approved modifications or alternate methods are consistent with the intent of the code; do not lessen health, safety, accessibility, life, fire safety or structural requirements; and that special conditions unique to this project make strict application of those code sections impractical.











FULL SIZE DRAWING IS 22" X 34" DRAWING: AS BUILT / DEMO SITE PLAN FOR PLANNING & ZONING
