Here is my latest damages claim for the City's OMF / Bureau of Revenue and Financial Services / Risk Management office for race track damages I've incurred in recent weeks during the current track season from not being able to be in my apartment on track race days.

Kenton, Portsmouth and St. Johns residents have been trying to address emissions of lead, CO2 and noise pollution from the track for many years. People have moved because of it. I live in a low-income, intergenerational community of elders and foster families, directly in the track's noise blast zone, as do New Columbia's children and elders. With races like the recent grand prix race weekend, everyone on the North Portland Peninsula and beyond heard the roar. It was horrific. As I've written many times, these races most negatively impact elders and youth.

Race track facts:

 Leaded fuel from these races covers a 25 mile radius around the track, according to Cornell researchers.

- Each gallon burned emits about 20 pounds (9 kilograms) of carbon dioxide, so that's about 120,000 pounds (54,431 kilograms) of CO₂ for a race weekend
- The theory offered by the economist, Rick Neivn, is that lead poisoning accounts for much of the variation in violent crime in the United States..
