ORDINANCE NO.

*Accept a \$100,000 grant from U.S. Department of Justice, Drug Enforcement Administration for Operation Weed and Seed(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The U.S. Department of Justice, Drug Enforcement Administration is providing funds to prevent, control and reduce violent crime, drug abuse and gang activity in targeting high-crime areas.
- 2. The executive offices of Weed and Seed with the concurrence of the Drug Enforcement Administration has identified \$100,000 for the Portland Police Bureau to fund overtime and related activities associated with the Weed and Seed operation.
- 3. The grant application was approved through Oridance #171432 on July 30, 1997. The terms of this agreement will begin on October 1, 1997, and continue until September 30, 1998.
- There is no match requirement.

NOW, therefore, the Council directs:

- a. The Mayor is authorized to accept the cost reimbursement agreement between the Portland Police Bureau and the U.S. Department of Justice, Drug Enforcement Administration.
- b. An increase in appropriation for FY 97/98 and transfer of funds for the grant award is authorized as follows:
