

ORDINANCE No. 160470

- * Internal fund transfer to allow purchase of replacement tape recorder for Police Internal Investigations Auditing Committee (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Internal Investigations Auditing Committee (PIIAC) maintains taped records of its meetings.
2. The existing tape recorder is broken beyond cost-effective repair.
3. The FY 87-88 budget does not contain any allowance for capital equipment purchase or replacement.
4. There are sufficient funds available in 210/Professional services.

NOW, THEREFORE, the Council directs:

- a. The FY 87-88 budget is hereby amended to reflect the transfer of appropriation within the PIIAC budget as follows:

19000109 / 210	(\$600.00)
19000109 / 640	\$600.00

Section 2. The Council declares that an emergency exists because it is necessary to replace the tape recorder in order to facilitate and support the Committee's work; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
