

**ORDINANCE No. 158714**

An Ordinance amending Ordinance No. 158572, being an ordinance assessing, the cost of improving as a district: Streets within the SE Glenwood/85th District HCD Improvement Project (C-9540), by cancelling the charge to two properties and adding \$165.55 to Housing and Community Development costs.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 158572, passed by the Council June 4, 1986, assessed Tetonka Park, Block 3, except the north 47.5 feet of Lot 1 (DRN 36172) in the amount of \$102.30 and except the north 47.5 feet of the east 15 feet and except the north 44.5 feet of the west 25 feet of Lot 2 (DRN 36173) in the amount of \$63.25, for a drainage charge. These properties do not abut any of the streets actually improved in this project and should not be charged.
2. Housing and Community Development pays the cost of this project less the property owners' share, and \$165.55 should be added to their assessment (DRN 36192).

NOW, THEREFORE, the Council directs:

- a. The assessment to Tetonka Park, Block 3 except the west 47.5 feet of Lot 1, and Block 3 except the north 47.5 feet of the east 15 feet, and except the north 44.6 feet of the west 25 feet of Lot 2 be cancelled and the assessment to Housing and Community and Development be increased by \$165.55.
