ORDINANCE No. 158722

An Ordinance authorizing the appointment of Barbara Madigan to the top step of Housing and Community Development Coordinator position effective June 17, 1986, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Fy 85-86 third quarter ordinance approved reclassification of a Management Analyst position to Housing and Community Development Coordinator.
- 2. The Civil Service Commission approved this reclassification effective June 17, 1986, ordinance # 158708.
- 3. Barbara Madigan has been performing HCD Coordinator duties for years and has extensive experience and expertise in this area and should be granted the top step of this classification.
- 4. This position is funded through the Housing and Community Development Program and does not require General Funds.

NOW, THEREFORE, the Council directs:

a. That Barbara Madigan be granted the top step of the Housing and Community Development Coordinator classification as set forth in the current compensation plan of the City of Portland, effective June 17, 1986.

Section 2. The Council declares that an emergency exists in order that Barbara Madigan be fairly compensated without delay; therefore, this ordinance shall be in force and effect from and after its passage by Council.
