

ORDINANCE No. 158725

An ordinance amending Exhibit A of Ordinance No. 152321 to establish a new petty cash fund of \$100.00 and a change account of \$75.00 for the East Permit and Inspections Division of the Bureau of Buildings, authorizing a warrant for \$175.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The establishment of the East Permit and Inspections Division July 1, 1986 has created a need for an additional petty cash fund and change account for the Bureau of Buildings to meet incidental expenses and to make change for citizens paying for permits.
2. There is sufficient appropriation in the 1986/87 budget for the East Permit and Inspections Division.
3. The Director of the Bureau of Buildings recommends that this petty cash fund and change account be established.
4. Ordinance No. 152321 should be amended to establish a petty cash fund of \$100.00 and a change account of \$75.00 for the East Permit and Inspections Division.

NOW, THEREFORE, the Council directs:

- a. That a petty cash fund in the amount of \$100.00 and a change account in the amount of \$75.00 are hereby established for the East Permit and Inspections Division as follows:

- b. The Mayor and the Auditor are hereby directed to draw and deliver a warrant in the amount of \$175.00 to the East Permit and Inspections Division, said warrant to be charged to Petty Cash Special Appropriation, BUC No. 40600116.

Section 2. The Council declares that an emergency exists in order that there be no unnecessary delay in establishing the petty cash fund and change account for the East Permit and Inspections Division; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
