ORDINANCE NO. 158734

An Ordinance accepting a Warranty Deed in connection with the North Going Street Noise Mitigation Project, granted by Nina R. Betts designating and assigning property therein conveyed as public street area, accepting an easement for wall and drainage purposes, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Right-of-way was required for the North Going Street Noise Mitigation Project.
2. The Portland Development Commission acquired the necessary property from Nina R. Betts for the City of Portland; the grantor has been compensated and the Warranty Deed has been recorded in the Multnomah County Deed Records.
3. The Warranty Deed, which has been approved as to form by the City Attorney, should now be accepted for the purposes hereinafter described.

NOW, THEREFORE, the Council directs:

- a. The following described property is hereby accepted, designated, and assigned as public street area:

R/W #4032-11-1

Parcel I

A parcel of land in Section 21, T1N, R1E, W.M., Multnomah County, Oregon, more particularly described as follows:

Beginning at the southwest corner of Lot 4, Block 1, ETHEL LYNN ADDITION; thence N 00°13'00" E., 65.00 feet to the true point of beginning; thence N 76°18'24" E., 51.51 feet; thence S 00°13'00" W., 2.00 feet; thence S 76°18'24" W., 51.51 feet; thence N 00°13'00" E., 2.00 feet to the true point of beginning, reserving to grantor an easement to maintain, construct and reconstruct a lateral sewer line to N Going Street.

Parcel II

A parcel of land in Section 21, T1N, R1E, W.M., Multnomah County, Oregon, more particularly described as follows:

Beginning at the northeast corner of Lot 2, Block 1, ETHEL LYNN ADDITION, said point being the true point of beginning; thence S 89°56'31" W, 5.88 feet; thence S 76°22'28" W, 96.96 feet; thence S 00°13'00" W, 2.0 feet; thence N 76°22'28" E, 102.98 feet; thence N 00°13'00" E, 0.57 feet to the true point of beginning, reserving to grantor an easement to maintain, construct and reconstruct a lateral sewer line to N Going Street. (Granted by Nina R. Betts.)

- b. The following described easement is hereby accepted for wall and drainage purposes:

R/W #4032-11-2

A parcel of land in Section 21, T1N, R1E, W.M., Multnomah County, Oregon, more particularly described as follows:

Beginning at the southwest corner of Lot 4, Block 1, ETHEL LYNN ADDITION; thence N 00°13'00" E., 55.00 feet to the true point of beginning; thence continuing N 00°13'00" E., 8.00 feet; thence N 76°18'24" E., 51.51 feet; thence S 00°13'00" W., 8.00 feet; thence S 76°18'24" W., 51.51 feet to the true point of beginning. (Granted by Nina R. Betts.)

- c. The following described easement is hereby accepted for wall and drainage purposes:

R/W #4032-11-3

A parcel of land in Section 21, T1N, R1E, W.M., Multnomah County, Oregon, more particularly described as follows:

Beginning at the northeast corner of Lot 2, Block 1, ETHEL LYNN ADDITION; thence S 00°13'00" W., 0.57 feet to the true point of beginning; thence S 76°22'28" W, 102.98 feet; thence S 00°13'00" W, 8.00 feet; thence N 76°22'28" E, 102.98 feet; thence N 00°13'00" E, 8.00 feet to the true point of beginning. (Granted by Nina R. Betts.)

- d. The Auditor shall record a certified copy of this Ordinance and return one copy of the recorded Ordinance to the Right-of-Way Acquisition Section, Bureau of Transportation Engineering.

Section 2. The Council declares an emergency exists because a delay in accepting the Warranty Deed might cause confusion as to the City's rights; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
