

An Ordinance accepting a Street Deed for the future widening of SW Vacuna Street east of SW 27th Avenue, granted by G. Eldon Fix and Dorothea W. Fix, at no cost to the City, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Right of Way is required for the future widening of SW Vacuna Street east of SW 27th Avenue.
2. G. Eldon Fix and Dorothea W. Fix have conveyed the required right of way to the City at no cost to the City.

NOW, THEREFORE, the Council directs:

- a. That the following described tract is hereby accepted for street purposes.

R/W #4141

The south 25 feet of the following described tract of land in the City of Portland, Multnomah County, Oregon:

The west one-third of the northeast quarter of the south one-half of the east one-half of the northeast quarter of Section 32, T1S, R1E, W.M. (Mr. & Mrs. Fix, 11520 SW 27th Ave., Portland, OR 97219)

- b. The Auditor shall record in the appropriate deed records, documents of title as necessary for acquisition of this right of way, and return one copy of each recorded document to the Right of Way Acquisition Section, Bureau of Transportation Engineering.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the Street Deed might result in confusion as to the public rights in the street area; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
