

## ORDINANCE NO. 158754

An Ordinance amending Ordinance No. 158679, which granted a revocable permit to the State Games of Oregon to erect and maintain banners on City of Portland Street Light poles.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The State Games of Oregon wishes to hang banners on City street light poles, promoting the State Games playoffs July 25, 26, and 27, 1986.
- 2. Ordinance No. 158679, passed by the Council June 25, 1985, allowed banners to be attached to street light poles on S.W. Front Avenue from Madison to Pine Streets plus other street light locations in the downtown area.
- 3. State Games of Oregon would like to change one banner location listed on Ordinance No. 158679.

Now therefore, the Council directs:

- (a) Ordinance No. 158679 entitled "An Ordinance granting a revocable permit to the State Games of Oregon to erect and maintain banners on City of Portland street light poles from June 30, 1986 to July 28, 1986; and declaring an emergency", is hereby amended as follows:
  - Section 1-2a be amended retroactively by deleting S.W. Front, Madison to Pine, and substituting in its place, S.W. 6th Avenue, S.W. Alder to S.W. Salmon Streets.
  - (2) Insurance policy will be changed to reflect the above street deletion and substitution.
  - (3) All other conditions to Ordinance No. 158679 will remain in effect.

## **ORDINANCE** No.

Section 2. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in an unnecessary hardship of uncertainty on the part of the applicant as to the status of the requested permit; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
