

ORDINANCE No.**158759**

An Ordinance amending Ordinance No. 158638, being an ordinance assessing certain properties for nuisance abatement by cancelling the assessment for Central Albina, Block 5, Lot 5, in the amount of \$165.28, and reducing the total assessment by the same amount, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 158638, passed by the Council June 19, 1986, assessed Central Albina, Block 5, Lot 5, DRN 36263, in the amount of \$165.28 for nuisance abatement for the one-month billing period ended February 28, 1986, and entered in the City Lien Docket.
2. The property owner did the work himself, and there should not have been any charge.

NOW, THEREFORE, the Council directs:

- a. The lien of \$165.28 on Central Albina, Block 5, Lot 5, be cancelled and the total assessment reduced by the same amount.

Section 2. The Council declares an emergency exists because of the, necessity of keeping the city's financial records accurate; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
