## ORDINANCE NO. 158766

An Ordinance providing for the establishment and operation of a City-County Blue Ribbon Committee on Hunger, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Multnomah County has joined with the City of Portland to review what is needed to end hunger in Multnomah County.
- 2. Representatives of the Interagency Food Bank and other organizations have requested that Multhomah County and the City of Portland create a committee to examine longterm solutions to the problem of hunger in conjunction with the Emergency Basic Needs Committee which will be focusing on the coordination of emergency needs.
- 3. This committee shall address the following questions:
  - A. Why has there been a dramatic rise in the number of persons at risk of hunger in Multnomah County?
  - B. How can the problem of hunger be handled before it becomes an emergency?
- 4. This committee shall work in concert with the City/County Emergency Basic Needs Committee in coordinating research and creating solutions.
- 5. This committee shall prepare recommendations regarding solutions to the problem of hunger for the 1987 session of the Oregon State Legislature.
- 6. Staff support for this committee will be provided by Multnomah County.

NOW, THEREFORE, the Council directs:

- Multnomah County, with the City of Portland, hereby establish the City-County Blue Ribbon Committee on Hunger. The committee shall consist of twelve (12) members, to be appointed jointly by the County Executive and the Mayor of the City of Portland, with the approval of the Board of County Commissioners and the City Council.
- b. The terms of all members shall be five months commencing on the tenth day of July 1986.

- c. The committee shall report their findings and solutions in a written report to the City/County Emergency Basic Needs Committee, the City Council and the Board of County Commissioners in November of 1986.
- Section 2. The Council declares that an emergency exists in order to avoid undue delay in the establishment of the Committee on Hunger; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
