Section 1. The Council finds:

- Right-of-way was required for the North Going Street Noise Mitigation Project.

a. The following described property is hereby accepted, designated, and assigned as public street area:

Lots 1, 2, 3, and 4, Block 2, ERWIN & WATSON'S ADDITION TO ALBINA in the City of Portland, Multnomah County, Oregon; Excepting therefrom the following described property:

Beginning at the northwest corner of Lot 1, Block 2, ERWIN & WATSON'S ADDITION TO ALBINA; thence east 177 feet along the north line of Lots 1, 2, 3, and 4 in said Block 2, to a point which is 23 feet west of the east line of
