## ORDINANCE No. 158792

An ordinance amending Title 7 of the Portland City Code to reflect changes in auditing responsibility for utility fee payments and declaring an emergency.

The City of Portland ordains:

S 2 . 2

Section 1. The Council finds:

Following the recommendations of Internal Audit Report 2-85, responsibility for collecting, monitoring, and auditing utility fee payments has been assigned to the Bureau of Licenses. The City Code should be amended to reflect this change.

NOW, THEREFORE, the Council directs:

a: Title 7 of the Code of the City of Portland is amended as follows:

"Auditor" shall be replaced by "Bureau of Licenses" in the following sections, and appropriate indexes shall be amended to reflect this change: 7.12.030, 7.12.080, 7.14.060, 7.14.070. Additionally, "or designee" shall be added following "Bureau of Licenses" in the first instance in section 7.12.030.

Section 2. The Council declares an emergency exists because there should be no delay in amending the Code to reflect the intent of Council; therefore, this ordinance shall be in force and effect from and after its passage by Council.
