ORDINANCE NO. **158888**

An Ordinance establishing goals for the participation of Minority/Female Business Enterprises in the City's procurement processes; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance 150736 passed by the Council on November 12, 1980 adopted the Minority/Female Business Enterprise Information System relating to the City's affirmative action efforts through all procurement processes.
- 2. The management of this system requires that M/FBE participation goals be established annually by Council.
- 3. The Purchasing Agent has developed the City requirements, M/FBE capability, and M/FBE opportunities for participation in the City's purchasing program.
- 4. The Purchasing Agent has filed a report to Council (copy at see Cal. No. tached) that summarizes this information and makes recommenda- 5-1662-86 tions for the M/FBE participation goals.

NOW, THEREFORE, the Council directs:

- 1. The goals for M/FBE utilization in the City's procurement processes for FY 1986/87 be adopted as follows:
 - A. Minority Business Enterprises:

Construction	10%
Supplies	2.8%
Personal Services	20%
Professional, Technical and Expert Services	9%

B. Female Business Enterprises:

Construction	2.5%
Supplies	4.5%
Personal Services	3.7%
Professional, Technical and Expert Services	9%

ORDINANCE No.

- 2. The Purchasing Agent and all operating bureaus, offices and departments will seek to insure Minority/Female Business Enterprises participation in the City's procurement processes commensurate with goals.
- Section 2. So that there will be no delay in implementing these goals, the Council declares that an emergency exists and this ordinance shall be in force and effect from and after its passage by Council.
