## ORDINANCE No. 158894

An Ordinance repealing Ordinance No. 112487, which granted a revocable permit to Lloyd Corp. Ltd to pave and use certain dedicated street area between NE 15th Avenue and NE 16th Avenue and between NE Multnomah Street and NE Holladay Street, for parking purposes, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. Lloyd Corp. Ltd., 700 NE Multnomah Street #1050, Portland, Or 97232, requested permission to pave and use certain dedicated street area between NE 15th Avenue and NE 16th Avenue and between NE Multnomah Street and NE Holladay Street, for parking purposes.
- 2. By Ordinance No. 112487, passed by Council on September 1, 1960, a revocable permit was granted to Lloyd Corp. Ltd. for the purpose requested, under certain conditions.
- 3. That Ordinance No. 112487 is no longer needed for the purpose requested.

### NOW, THEREFORE, the Council directs:

- a. Ordinance No. 112487, entitled "An Ordinance granting a revocable permit to Lloyd Corporation, Ltd., 721 NE 12th Avenue, Portland 12, Oregon, to pave and use certain dedicated street area between NE 15th Avenue and NE 16th Avenue and between NE Multnomah Street and NE Holladay Street, for parking purposes, repealing Ordinance No. 112378, and declaring an emergency." is hereby repealed.
- Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary Ordinances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
