ORDINANCE NO. 158896

An Ordinance amending provisions of Title 25, Plumbing Regulations, of the Code of the City of Portland to require a \$1.00 assessment fee for each plumbing permit for the purpose of implementing recommendations of the Regulatory Review Committee specifically intended to assist the development community interface with the City's review/approval processes; effective August 18, 1986, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Regulatory Review Committee studied the City's permit and inspection processes and recommended that written resources be developed to assist permit applicants in meeting the City's requirements.
- In September 1984, the City Council adopted the Regulatory Review Committee's recommendation that a development manual be compiled outlining the City's construction and permit requirements.
- 3. These resources will save both the permit applicant and the City time, and, therefore, assist in making the City more attractive to construction development.
- 4. The City Council gave the Bureau of Buildings authority to develop these resources through the fiscal year 1986-87 budget.
- The Council also directed that a \$1.00 fee be charged for each plumbing permit to fund these resources.

Now, THEREFORE, the Council directs:

- a. That Section 25.05.060, Fees, of Chapter 25.05, Permits, of the Code of the City of Portland, Oregon be amended and said section shall hereafter read as follows:
 - (18). Regulatory Review Assessment. A \$1.00 assessment will be added to the cost of each plumbing permit for the purpose of financing the implementation of the Regulatory Review Recommendations intended to assist permit applicants with the City's review/approval processes.

ORDINANCE No.

Section 2. The Council declares that an emergency exists, because the fee schedule was included in revenue estimates for the fiscal year beginning July 1, 1986, therefore, this ordinance shall be in force and effect on August 18, 1986.
