

ORDINANCE No. 158901

An Ordinance amending the Compensation Plan, establishing the salary rate for the classification of Affirmative Action Officer effective July 1, 1986, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Personnel Services has reviewed the duties and responsibilities of the classification of Affirmative Action Officer (Job Class No. 0624) and recommends a salary as shown below:

<u>Entry</u>	<u>After 1 Yr.</u>	<u>After 2 Yrs.</u>	<u>After 3 Yrs.</u>
16.11	17.13	18.12	19.23

2. The City Council approved in the Fiscal Year 1986-87 budget an amount sufficient to cover the cost of this salary adjustment specifically defined as the salary for this position.


NOW, THEREFORE, the Council directs:

- a. The Compensation Plan be amended to reflect the newly established salary for the classification of Affirmative Action Officer.
- b. This salary is to be effective July 1, 1986.

Section 2. The Council declares that an emergency exists because the new salary rate should be adopted without undue delay, therefore this Ordinance shall be in force and effect from and after its passage by Council.
