

**ORDINANCE No. 158933**

An Ordinance amending Ordinance No. 158886, being an ordinance assessing certain properties for sidewalk repairs by cancelling the assessment for P. T. Smiths Addition, Block 3, Lot 4, in the amount of \$3,311.77, and reducing the total assessment by the same amount, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 158886, passed by Council on August 13, 1986, assessed P. T. Smith's Addition, Block 3, Lot 4, DRN 36,853, in the amount of \$3,311.77 for sidewalk repair for the billing period ended May 31, 1986, and entered in City Lien Docket Book No. 134, page 140.
2. As the result of the settlement, Circuit Court Case No. A8412-07519, this lien has been paid and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

- a. The lien of \$3,311.77 on P. T. Smith's Addition, Block 3, Lot 4, be cancelled and the total assessment reduced by the same amount.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
