- WHEREAS. in the course of his career, Lloyd Anderson has served the public interest in positions of leadership at state, regional and local levels, and
- WHEREAS, as City of Portland Commissioner of Public Works, 1969 - 1974, Lloyd Anderson demonstrated and acted upon concern for the environment and the future of the City,
- WHEREAS. Commissioner Anderson recognized the need to go beyond simple screening and chlorination to secondary treatment in the City's sewage treatment system and was instrumental in obtaining Council and citizen approval and funding so that those improvements could be made, and
- WHEREAS. under the leadership of Lloyd Anderson, the City of Portland transitioned to a modern sewerage treatment system, constructing not only secondary treatment facilities, but major sewage interceptors and obtaining the equipment and technical ability to expand the system, and
- WHEREAS. the citizens of the City of Portland have been enriched by the contributions of Lloyd Anderson and his concern for the community and the environment throughout his career, and
- WHEREAS, a bicycle and pedestrian bridge is being constructed by the Bureau of Environmental Services across the Columbia Slough near the Columbia Boulevard Wastewater Treatment Plant (CBWTP) in connection with the Inverness Force Main Project, and
- WHEREAS. the bridge will provide a vital link in the urban trail system between the Peninsula Crossing Trail, the 40-Mile Loop Trail, and points between the Willamette and Columbia Rivers in north Portland, and
- WHEREAS, it would be fitting to recognize Lloyd Anderson for his contributions to the community and his efforts to promote a cleaner and healthier environment,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Portland, Oregon, that the bike and pedestrian bridge across the Columbia Slough at CBWTP be named the Lloyd Anderson Bike and Pedestrian Bridge in honor of Mr Anderson's vision and leadership on behalf of the citizens of this City
