#### NOVEMBER 8, 2006 9:30 AM

Saltzman: Both commissioner Adams and mayor Potter are excused. We do have -- nobody signed up today. So we'll go straight to our time certain. 9:30 time certain. Item 1482.

**Saltzman:** Today's item was scheduled with the property owners before it was known commissioner Adams would be absent today of the we wanted to avoid rescheduling this item and having to renotify the property owners. Commissioner Adams will be present for the l.i.d. formation hearing on december 6, which will be scheduled if today's resolution is approved. I'll turn it over to andrew aebi to give a presentation to us.

Andrew Aebi: The resolution today accepts the petitions of support that have been received for this project. Karla is passing out a map of the project area. The project itself is actually quite small. A portion of north Winchell Street between minnesota and montana has already been improved via permitted frontage improvements. The neighbors on the western portion of the block would like to finish the street improvements along the remainder of the block. We went through a petition effort last year that was not successful, and therefore was not brought to council for consideration. I was contacted by three of the property owners several months ago asking that we repetition the l.i.d. Which we did, and we -- as a result we got 50% petition support and 12.8% waiver support for total support of 62.8%. And the map in front of you shades the properties that have tendered their petition support and their waiver support for the project. I'm not aware of anybody who is opposed to this project moving forward. The street as it currently exists has existing pavement that's in atrocious condition, and there's no storm water drainage to speak of on the street. Basically the area between the curb and the existing pavement and people's front yards is where the storm water is going now. So the purpose of this project is to bring the street up to full city standards and to provide for storm water disposal and the scope of the project and anticipated vegetated swales and sustainable storm water options for doing with the storm water. If council doesn't have any questions for me, we have several property owners who are here to speak.

Saltzman: Questions? Thanks, andrew. Do we have people here to testify?

**Mitch Schaub:** Good morning. Mitch, I live at 1247 north winchell, and as andrew said, we have a street that is in very bad shape, and we encourage council to approve our request for an l.i.d., and in its current shape we the homeowners feel that by and large the street is unsafe. We have children in our street that have nowhere to go when traffic comes by. There's no sidewalk for instance, for safety. There's no curb or gutter, so the marcation between street and cars and safety is just not there. And so again, I would just like to point that out and to say that we encourage passage of this so that we can move forward and as we move forward, understand that the construction is scheduled for this is several construction seasons away, perhaps several years, and we will be working with pdot and other agencies in town to help us with the -- pursue all avenues of helping us with the funding for this, because it is -- as the estimate is provided for, our portion of the improvements is not a small pill to swallow for the homeowners as a cost item, so I wanted to bring that to your

attention that we will be working with pdot and the different agencies hopefully to explore and secure additional help and payment for this.

Saltzman: Thank you very much. Any questions?

**Schaub:** Thank you for the opportunity to talk.

**Susan Oliver:** Hi. I'm susan oliver. I am -- susan oliver, the property owner of the white bungalow at 1268 north winchell. These are my pictures. I'm glad you've taken a look. I saw some of your looks another horror at the veritable ocean that opens up when we have rain there. That is in my neighbor's driveway. It's really, really, really bad. So mitch brought up the safety concerns. Those are definitely a concern. We have some children on the street now, we also have some younger couples and we expect them to grow into families as the years go by, and it would be really nice if they could safely play in the street like other kids do without the fear of breaking their ankles when they step into one of these potholes. I'm also excited about, well, firstly the sheer aesthetics of it, going from something that looks like this to something that has smoothness and street trees, and cubs and gutters and all those wonderful things. Those are the kind of things we need in north Portland to bring up property values and encourage businesses to relocate there, etc. So as a homeowner and a property owner, i'm really looking forward to that aspect of the street improvement. So I would ask of you, please approve our petition, and we'll see you again on december 6.

**Saltzman:** Thank you. Is there anybody else that wishes to testify? Ok. This will proceed to -- **Moore:** This is a resolution.

**Saltzman:** So we need to vote to approve it and send it for a formal hearing on the 6th? **Moore:** Yes.

To point out some of their mwesb activity, they're going to sub out the paving activity to a state-owned women enterprise. I might -- I have a representative from b.e.s. Here, technical questions i'm not able to answer.

Saltzman: So the full amount there, subcontracting is going to a woman-owned business? Baer: Yes.

Saltzman: Great. Any other questions? Great. Karla, please call the roll.

Moore: I didn't have a sign-up sheet, but if anybody wanted to testify --
