The Hearings Officer, on substantial evidence and based upon the record as a whole, finds as follows:

Ms. Potts-Taylor did not appear. Officer Deborah Barkley appeared on behalf of the City of Portland and testified. Exhibits 1-7 were admitted.

Ms. Potts-Taylor's car was parked on NW Couch between 17<sup>th</sup> and 18<sup>th</sup> at 7:30 am on August 8, 2008. It was towed from that location at or about 7:47 am on August 8, 2008. This area, including this location, was posted no parking at the time of the tow and the no parking signs had been placed and verified on or before August 6, 2008 by City of Portland Parking Enforcement, more than 24 hours before the tow. Portland City Code 16.30.210D requires that the barricades/signs be placed 24 hours in advance of the tow.

Therefore, it is ordered that all towing and storage charges against the vehicle shall remain the responsibility of the vehicle's owner.

This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
