HEARINGS OFFICER'S ORDER

APPEAL OF NORINE R. ARNTSEN

CASE NO. 1080244

DESCRIPTION OF VEHICLE: Mercury Villager (OR WAH898)

Decision Without Personal Appearance

HEARINGS OFFICER: Ms. Helle Rode

The Hearings Officer, on substantial evidence and based upon the record as a whole, finds as follows:

By letter dated August 20, 2008, Exhibit 12, Ms. Arntsen requested that a decision be made without her appearance. Exhibits 1 -22 were admitted and considered.

Ms. Arntsen's vehicle was parked on NW Marshall St., near the intersection of NW 19th from August 6 to August 8, 2008 at 9:53 am, at which time it was towed. Barricades stating that no parking was allowed in this area on August 8, 2008 between 7:30 am and 10 am were posted and verified on or about August 6, 2008, more than 24 hours before the tow. Portland City Code 16.30.210D requires that the barricades be placed 24 hours in advance of the tow.

Therefore, it is ordered that all towing and storage charges against the vehicle shall remain the responsibility of the vehicle's owner.

This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
