HEARINGS OFFICER'S ORDER

APPEAL OF JOY EGGERICHS

CASE NO. 1080265

DESCRIPTION OF VEHICLE: Mazda 3 (OR 885DNS)

The Hearings Officer, on substantial evidence and based upon the record as a whole, finds as follows:

Ms. Eggerichs appeared and testified on her own behalf. Parking Patrol Deputy Barklay appeared and testified on behalf of the City. The Hearings Officer makes this decision based upon the testimony of Ms. Eggerichs and Deputy Barklay, and the exhibits admitted into the evidentiary record (Exhibits 1 through and including 9).

Deputy Barklay testified that she cited, multiple times, Ms. Eggerichs' vehicle for being parked in a 1 hour limit zone for more than 1 hour. Deputy Barklay acknowledged that Ms. Eggerichs' vehicle had an "L" zone parking permit displayed. However, Deputy Barklay testified that the "L" zone permit (stated on the back of the permit) does not allow parking in violation of posted parking restrictions, such as the 1 hour time limit.

The Hearings Officer finds that Ms. Eggerichs did not intentionally violate any City of Portland parking restriction. However, it appears to the Hearings Officer, that Ms. Eggerichs was not fully informed of the limitations of the "L" zone area parking permit; in particular that she could not park her vehicle, even with the "L" zone permit, in the 1 hour limit area for an excess of 1 hour.

The Hearings Officer finds that Deputy Barklay followed the relevant laws/rules when ordering the tow of Ms. Eggerichs' vehicle on August 12, 2008. The Hearings Officer finds the tow valid.

Therefore, it is ordered that all towing and storage charges against the vehicle shall remain the responsibility of the vehicle's owner.

This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
