# **HEARINGS OFFICER'S ORDER**

APPEAL OF VERONICA AMADOR

# CASE NO. 1080288

## DESCRIPTION OF VEHICLE: Chrysler Concorde (OR 601CFM)

## DATE OF HEARING: September 18, 2008

The Hearings Officer, on substantial evidence and based upon the record as a whole, and receiving Exhibits 1 through 5 and 9 through 16 into the record without objection, finds as follows:

The Hearings Officer found that documentation provided by the appellant (Exhibits 15 and 16) was sufficient to show that she owns the subject vehicle.

The appellant objected to Exhibits 6, 7, and 8, arguing that they were not relevant to the case. Exhibit 6 contained the results of an alcohol breath test. The Hearings Officer could not determine who the breath test results were for, and kept it out of the record because it did not appear to be relevant. Exhibits 7 and 8 indicate a different vehicle from the subject vehicle. The Hearings Officer found that Exhibits 7 and 8 were not relevant to the case.

The officer's report (Exhibits 9 through 13) stated that the appellant's vehicle matched the description of a vehicle that was believed to have been involved in a hit and run accident with another vehicle, and was believed to have been driven by a man who attacked and robbed another person with a gun. Another officer a few blocks away reported a shooting and seeing two men running into the appellant's brother's home. The officer thought the two men might match the description of men involved in the hit and run and robbery incidents. The vehicle was towed as evidence.

The appellant stated during the hearing that the vehicle should not have been towed because it had been parked on the curb in front of her brother's house during the time that the hit and run and robbery took place. She also stated that while her vehicle was being towed, she told an officer at the scene that it was her vehicle. The appellant stated that the two men the officer saw at her house did not enter her house. The city code allows an officer to tow a vehicle without notifying the owner first if the officer reasonably believes that the vehicle is, or contains, evidence of a crime. The Hearings Officer finds that the officer had a reasonable belief that the vehicle was evidence of a crime. The vehicle appeared to match the description of the vehicle reportedly involved in a hit and run and a robbery. The gunfire and possible suspects in the area of the appellant's brother's house indicated that the appellant's vehicle might be the vehicle the officers were looking for.

Given these circumstances, this was a valid tow. Please note the relevant city code sections below concerning this matter.

#### 16.30.220 Towing Without Prior Notice.

(Amended by Ordinance Nos. 165980, 170912, 176352, and 176442, effective May 1, 2002.) Any authorized officer may, without prior notice, order a vehicle towed, when:

**G.** A police officer reasonably believes that the vehicle or its contents constitute evidence of any offense, if such towing is reasonably necessary to obtain or preserve such evidence;

Therefore, it is ordered that all towing and storage charges against the vehicle shall remain the responsibility of the vehicle's owner.

This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
