HEARINGS OFFICER'S AMENDED ORDER

FINDINGS OF FACT AND CONCLUSIONS OF LAW:

On April 23, 2009, Mr. Liefeld filed a Motion to Amend the Hearings Officer's Order (Exhibit 40) in the above-captioned matter. Mr. Liefeld requested that the Hearings Officer Amend the Order issued on February 9, 2009 ("Original Order") references to an April 30, 2009 deadline with a June 30, 2009 deadline. Mr. Liefeld indicted that ownership of the Subject Property (2910 SW Canterbury Lane, Portland, Oregon) has transferred and the new owner is processing a demolition permit which, when competed, would correct all violations referenced in Exhibit 1a. The Hearings Officer finds it appropriate to amend the Complaint to add, as an additional named respondent, Mr. Robert M. Stansel.

The Hearings Officer finds Mr. Liefeld's request to modify the Original Order to extend the time of suspension of a \$20,000 civil penalty until June 30, 2009 is reasonable and appropriate given the change of ownership of the Subject Property. The Hearings Officer finds that the Original Order shall remain in full force and effect unless specifically modified by this Amended Order.

ORDER AND DETERMINATION:

1. Paragraph 3 of the Original Order is modified by replacing all references to April 30, 2009 with June 30, 2009 and references to May 1, 2009 are replaced with July 1, 2009.

- 2. Paragraph 4 of the Original Order is modified by replacing all references to April 30, 2009 with June 30, 2009 and references to May 1, 2009 are replaced with July 1, 2009.
- 3. The Hearings Officer retains jurisdiction until July 17, 2009.
- 4. The Complaint (Exhibit 1) is amended to add Mr. Robert M. Stansel as an additional named Respondent.
- 5. All findings and orders contained in the Original Order shall remain in full force and effect unless specifically modified in this Amended Order.
- 6. This Amended Order has been mailed to the parties on May 1, 2009, and shall become final and effective immediately. This case will be closed on July 17, 2009.
- 7. This Amended Order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et. seq.
