DEED FOR RIGHT-OF-WAY PURPOSES

KNOW ALL PERSONS BY THESE PRESENTS, that THE PORT OF PORTLAND, a port district of State of Oregon, ("Grantor"), in consideration of the sum of TWO HUNDRED THIRTEEN THOUSAND DOLLARS AND NO CENTS (\$213,000.00) and other good and valuable consideration to it paid by the City of Portland, a municipal corporation of the State of Oregon("City"), the receipt whereof is hereby acknowledged, hereby conveys unto the City of Portland, which purchases pursuant to its eminent domain power and authority, an easement for public street and right of way purposes in the real property, being particularly described as Parcels 1, 2, 3 and 4 as follows ("Subject Property") and depicted on Exhibits A1, A2, A3 and A4 attached hereto and by this reference made a part hereof:

Parcel 1

CONTAINING AN AREA OF 31,847 SQUARE FEET, MORE OR LESS.

TO HAVE AND TO HOLD, the same easement to the City of Portland for the uses and purposes aforesaid forever.

A. Grantor represents that to the best of its knowledge after appropriate and reasonable inquiry under the circumstances, the subject property is in compliance with all local, State and Federal environmental laws and regulations.

- B. Grantor represents after reasonable inquiry under the circumstances and to the best of its knowledge, that it has disclosed all knowledge of any release of hazardous substances onto or from the subject property, and disclosed any known report, investigation, survey, or environmental assessment regarding the subject property. "Release" and "Hazardous Substance" shall have the meaning as defined under Oregon law.
- C. After reasonable inquiry and to the best of Grantors knowledge, Grantor represents that there are no underground storage tanks, as defined under Oregon law, presently on or under the subject property.
- D. It is understood and agreed that the City, by accepting this dedication, is not accepting any liability for any release of hazardous substances onto or from the subject property, and that the Grantor is not attempting to convey any such liability.
- E. To the extent permitted by the law, the Grantor, its successors and assigns, agree to defend, indemnify and hold harmless the City, its officers, agents, and employees against all liabilities, damages, losses, claims, demands, actions, and suits (including attorney fees and costs) resulting from the presence or release of hazardous substances onto or from the subject property. This provision shall not apply to a release of hazardous substances onto or from the subject property caused by the officers, agents or employees of the City. Any action taken pursuant to this provision shall not constitute an admission of liability or waiver of any defenses to liability.
- F. To the best of its knowledge, Grantor represents and warrants that it has the authority to grant this easement.
- G. This Effective Date shall be the date this easement is signed by all parties.






