#### **HEARING OFFICER'S FINAL ORDER**

#### FINDINGS OF FACT AND CONCLUSIONS OF LAW:

An Interim Order was issued on May 4, 2009. The Interim Order required Respondents to make corrections to matters set forth in Exhibit 1a and assessed civil penalties. Paragraph 3 of the Interim Order imposed a \$10,000 civil penalty to become due on June 16, 2009.

Ms. Whelan, the City of Portland Bureau of Development representative, submitted a document on June 16, 2009 stating that "all, or substantially all, of the violations described in Code Violation complaint have been corrected." (Exhibit 42) Exhibit 42 also stated that the civil penalty to be imposed on June 16, 2009 "may be waived."

The Hearings Officer, based upon Exhibit 42, finds that all or substantially all of the violations listed on Exhibit 1a have been corrected and that the civil penalty due on June 16, 2009 should be waived. The Hearings Officer on his own motion admitted the remaining Exhibits 40 through and including Exhibit 42 into the evidentiary record. The Hearings Officer finds that this case should now be closed.

### ORDER AND DETERMINATION:

- 1. This case shall be closed on June 18, 2009.
- 2. This order has been mailed to the parties on June 18, 2009 and shall become final immediately.
- 3. This Order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
