He said they are still studying whether it is constitutional to prohibit unloaded weapons in cars in parks and, if so, will return with another amending ordinance. However, in the meantime, passage of this ordinance is proposed with one amendment -- substitution of the word "upon" for "on" in subsection B.

Commissioner Blumenauer moved the amendment. Commissioner Kafoury seconded and the motion carried. (Y-5)

# **Commissioner Gretchen Kafoury**

Appeal of the Oregon Food Bank against the Noise Review Board's decision on variance application for Waterfront Blues Festival (Previous Agenda 861)

**Discussion:** Larry Scruggs, Noise Review Board Chair, said the Board approved the variance for the Blues Festival for all the times requested except for four hours, from noon to four p.m., on Friday, July 3. He noted numerous complaints received last year about events in Waterfront Park, many of which revolved around this particular event. The Board felt that granting the variance for Friday afternoon would have too significant a noise impact on businesses and hotels.

Commissioner Kafoury asked why the daytime hours are more of a problem than the nighttime hours.

Mr. Scruggs said businesses are impacted more during the day while the residential impact is more significant in the evening. He said complaints received from the Marriott and the Alexis hotels stated that the noise was too great. He said the Blues Festival had agreed to reduce the hours the Festival would run in the evening.

Commissioner Bogle asked if it were possible to have two decibel levels for different hours.

Mr. Scruggs said yes, the Board is asking that the Festival comply with existing noise Code which specifies a sound level of 60 dBA before 6 p.m. He said the Festival requested 70 dBA from noon to 4 p.m. on Friday, July 1, noting that 70 dBA is twice as loud as 60.

Bill Dickey, Assistant Event Coordinator for Oregon Food Bank for the Waterfront Blues Festival, said they are asking Council to review denial of the noise variance for Friday afternoon, July 3. He said not having the variance will put a serious strain on the Food Bank's ability to collect food donations during that time period. He said they have worked very closely with the Noise Review Board to make this event work, including spending additional monies for sound technology and staging in order to meet the variance's strict requirements.

Mr. Dickey said this year, in response to last year's complaint from occupants at the Ben Franklin Building, they notified every tenant and

received only one letter of complaint. He said July 3 is a bank holiday and downtown usually slows down on such days. He compared the Blues Festival to other events, such as Cinco de Mayo, which operated on both Thursday and Friday afternoon in a similar neighborhood. Mr. Dickey said he believes their festival is taking the heat for other festivals that have not acted as responsibly as they have.

Commissioner Bogle asked about the sound level last year and for more details on the notification sent to Ben Franklin tenants.

Mr. Dickey said the dBA last year was 75. He said they notified approximately 200 tenants in the Ben Franklin Building and received five responses - three positive and two negative. He said without the variance for Friday afternoon, Festival organizers believe they will lose about \$10,000 in food donations.

Mayor Clark asked why the noise level could not be kept to 60 dBA.

Mr. Dickey said he does not think musicians can play amplified at that level.

Paul Herman, City Noise Control Officer, said there are two stages and the music switches from one to the other so that there is no down time. He said a number of the complaints, particularly from the Marriott, had to do with the unrelieved aspect of the noise and were specific to this event.

Tom Robinson, owner of Concert Sound and chief engineer for the Blues Festival sound system, said the Blues Festival is the most technologically difficult of the festivals to put on and much time and money has been spent on noise containment. He said 75 dBA is a very reasonable sound level, while 60 is below the ambient traffic level on the street.

Andrew Newman, 1731 NW Everett St., #111, stressed the humanistic reason for holding the Festival -- to raise money for food to feed the homeless and hungry.

Craig Mayther, 1017 SE 33rd, said the Blues Festival is the largest such festival in the West and raised over \$60,000 last year. He said sound was constantly monitored by the Festival organizers in order to cooperate with City noise requirements. Mr. Mayther said he started circulating a petition favoring the appeal and collected over 300 signatures in about a week.

Jeffrey Dawkins, Back Porch Blues, said this event is one of the major Blues Festivals in the country. He asked Council to grant the Food Bank's request in order to help Portland's underclass. He said the festival workers work hard to maintain user-friendly sound levels.

Nina Vallioan, Riverplace Cafe & Deli, said she does not believe the festival is disruptive. She said if you are downtown it is going to be noisy and if you want quiet you should move to the suburbs.

Mayor Clark asked if there was a way to allow for breaks, so there could be some intervals of quiet.

Dave Clingan, Festival talent coordinator, said one of the unique appeals of the Festival is that music goes on all the time.

Commissioner Kafoury asked whether it had been held on a holiday before and whether there had been complaints then.

Mr. Herman said it had been held on a holiday and there had been complaints. He said the Noise Review Board was most concerned with businesses that would be open on Friday. He said last year complaints came from higher floors at the Ben Franklin and they also received a number of complaints from residential high rises. He said in its decision not to grant the variance requested for Friday afternoon, the Board was looking at a way of giving some relief to some people.

Commissioner Kafoury moved to overrule the Noise Review Board's decision. Commissioner Bogle seconded.

Commissioner Lindberg said he will vote to grant the appeal because he believes the organizers have made exceptional efforts to reduce the noise and because the request is for an afternoon that is a legal holiday.

He said the covenant was sought because environmental zoning, which now overlays the property, was not in effect at the time application was made for the planned unit development.

**Disposition:** Passed to Second Reading May 20, 1992 at 9:30 a.m.

Commissioner Bogle moved to suspend the rules to hear from residents of North Portland regarding the Asian gypsy moth spraying program. Commissioner Kafoury seconded and the motion carried. (Y-5)

**905-1** Hear from North Portland citizens regarding the Asian Gypsy Moth spraying program (Report)

The following citizens called for a stop to the spraying program:

Delores Eaves, 409 N. Tyler Grace Papour, no address given Sandy Trapnell, 9406 N. Tyler Adele Kaptur, 6841 N. Newcastle

Opponents cited respiratory and other health problems as a result of the spraying and complained that prior notice was not always given before the spraying began.

Jay Ward, 8120 SW 56th, said federal and state agencies have run roughshod over the concerns and questions of North Portland residents. He said he has no problem with site specific application of B.t but this

massive application is ineffective and an overreaction which harms people.

Commissioner Lindberg said State officials informed him that they have not been receiving calls from doctors reporting harmful effects.

Mr. Ward said he contacted several emergency rooms and learned they are not tracking this as yet. He urged revocation of low flight helicopter flights until the State answers the many questions that have been raised. He also asked why the Toyota and Steinfeld properties were exempted from the program.

Mayor Clark said he would inquire into this.

Commissioner Kafoury said it is difficult for Council to change things when all the reports are anecdotal and medical corroboration is lacking.

Mr. Ward said the burden of proof should be on the State to show that it is safe, not the residents.

Michael Vernon, operator of a hot line for residents, said he set up the line because the State's hot line was always busy or disconnected. He said residents have been unable to get accurate information about spraying dates and locations from the Department of Agriculture.

Commissioner Bogle asked about the nature of the 56 calls cited by Mr. Vernon.

Mr. Vernon said there were 56 calls which were directly health related. He said he has names and numbers.

Commissioner Bogle asked how many of the 56 went to physicians.

Mr. Vernon said very few because most could not afford it but one elderly women had to go to emergency. He said the Oregon health department has finally acknowledged that there might be some problems.

Pam Arnold, Kenton Neighborhood, said the State sprayed the Heron Golf Course during the daytime hours, adding that the accuracy of information they are getting is intolerable.

Commissioner Kafoury said it is within our jurisdiction to ask the State for a better response and better information.

Commissioner Blumenauer said that should be a condition of the permit and if they are violating it, then they should not fly.

Mayor Clark agreed and said he would contact the State about this.

Mr. Auerbach said he recalled that the City did not itself grant a permit but instead gave consent to the Federal Aviation Authority to grant one for a low-flight helicopter flight.
