Discussion: Commissioner Lindberg said this would allow a temporary concession contract for rollerblade rentals on the Esplanade within Waterfront Park.

Harry Auerbach, Deputy City Attorney, said this would be an interim measure that would be in effect until July 1 when the new Title 16 takes effect. He said the Downtown Traffic District, where skating is prohibited, has been redrawn to end at Front Avenue so the Esplanade would not be a part of it. Commissioner Lindberg said a Task Force has been formed because of complaints about bicycling and rollerskating on the Esplanade and in front of River Place.

1048 TIME CERTAIN: 9:30 AM - Transmit report for North Macrum, NE 22nd Avenue and SE 55th Avenue (Report introduced by Commissioner Blumenauer)

Discussion: Commissioner Blumenauer said no one is surprised that speeding is a major neighborhood concern. He said in an attempt to solve the problem, the Bureau of Transportation has developed a program that appears to meet the needs of citizens.

Donna Green, Planner with Neighborhood Traffic Management Program, (NTMP) said all procedures prescribed in the NTMP were followed for these three projects. All three involve streets tested for speed bumps, which prior to this time had not been used as traffic management devices in the City. She reviewed the speed bump tests, noting a reduction in speeds on the test streets of between six and nine miles per hour as well as favorable responses to their use from the Fire and Police bureaus and other groups. Ms. Green said residents on all three streets voted overwhelmingly to keep the street bumps, which cost an average \$1600.

Marilee McIntee Dolph, 1107 SE 55th, supported retention of the speed bumps on SE 55th. She said speed bumps have reduced speed up to 11 miles while still allowing full use of the street. She said 87 per cent of residents favor this project.

Kent Barnes, 5535 SE Salmon, said since the speed bumps have gone in, speeds have been reduced. He said he thinks the bumps should be spread to other neighborhoods.

Commissioner Blumenauer said acceptance of this report signals that the speed bump program will be integrated as an ongoing part of traffic management policy.

1049 Transmit Citizen Advisory Committee Report on NTMP (Report introduced by Commissioner Blumenauer)

Discussion: Janice Newton, Neighborhood Traffic Management Program, said this report contains responses to public testimony given at the March 11 Council hearing on the report and recommendations of the Citizen Advisory Committee. Ms. Newton reviewed the issues raised at the time, including the cost of the

NTMP program and the traffic devices. She said this information will be included in future Citizen Advisory Committee reports and traffic committees will have cost data on each project prior to voting. Regarding the proposal to include neighborhood associations in the final balloting for an NTMP project, Ms. Newton said they believe that residents on the streets where the projects are built should be the ones to vote. A third issue called for the elimination of the NMTP and removal of traffic management devices and circles. She said as part of the NMTP evaluation a consultant was hired to evaluate all traffic circles.

Results of the study by Kittelson, Inc. clearly demonstrated that traffic circles reduce speeding and traffic accidents.

Discussion: Ms. Newton said the changes in policies and procedures include more emphasis on pedestrians, guidelines for what is acceptable diversion, revised voting procedures, focus on consensus building between the City and Traffic Committee, and addition of an evaluation and monitoring process,

Commissioner Blumenauer expressed his appreciation to Ms. Newton for her work on this program.

Discussion: Commissioner Kafoury said at long last they have a contract for this program.

Donna Schultz, Youth Employment Coalition, said the coalition is a group of about 15 citizen volunteers who lobby companies for jobs. Companies that have already agreed to participate include Nike, Nordstrom and Kienows.

Sam Pierce, co-chair Youth Empowerment Task Force, said right now they have 25 jobs committed and have hired 10 kids. He said this program is working despite skepticism about hiring at-risk kids.

City Auditor Barbara Clark

1088 Create the SW Lower Drive and Private Property Local Improvement District and provide for constructing a sanitary sewer (Hearing; Ordinance; C-9759)

Discussion: Mary Nolan, Director of Environmental Services, said this is a petition presented by private citizens to replace a broken antiquated sewer

system. She said this is a textbook example of a series of decisions that made sense individually but collectively result in a circumstance that no one involved believes makes sense. She said the Bureau is primarily concerned with addressing public health concerns and being responsible to the rate payers. She said she is here today to find a solution which serves all objectives, even though all the details may not be resolved today.

Commissioner Blumenauer said he hopes that a workable proposal can be presented at next week's Council meeting.

Lee Klingler, Project Manager, said this sewer was built in 1912 as a private sewer line in a rugged steep area. In 1987, after the City found that the system had failed and was leaking sewage, residents met to form a Local Improvement District (LID) in 1987 and it has taken until today to come up with a solution. He reviewed concerns, including finding an equitable assessment method and noted that the City Auditor did an area assessment after reviewing and rejecting other methods. Some participants have requested a subsidy program similar to what was done in Mid-County but the Bureau believes this project differs from Mid-County in that residents there had a working sewer system and also were under state mandate because of a perceived threat to regional drinking water. The Bureau also believes that records show that this is a private sewer and the City Attorney concurs although there is always a question since the system is so old. Another issue raised deals with the appropriateness of placing a sewer in an environmental protection zone. Six of the 12 property owners have remonstrated against the project. Most want the sewer but are remonstrating because of its cost.

Commissioner Lindberg asked if it was mandated because of state laws.

Mr. Klinger said it is definitely a local health problem but there is no state mandate.

Commissioner Blumenauer said raw sewage is coming to the surface but there is no regional contamination. He said the current situation, however, is absolutely unacceptable and must be remedied.

Susan Feldman and Al Burns, Bureau of Planning staff, said the presence of the sewer in the environmental overlay zone requires an environmental review which involves a public review process.

Commissioner Kafoury asked if there was anything Council could do to speed the process.

Ms. Feldman said they will do it as fast as they can while still meeting public notification requirements. There is a concern that BES will have to demonstrate that there is no other alternative to going through the protection zone.

Commissioner Blumenauer said they also need to review with City Attorney and other bureaus a potential amendment to the environmental protection regulations that may be needed when health hazard issues arise, as they have in this case.

Harry Auerbach, Deputy City Attorney, said the City Attorney's office has already issued two opinions that utilities in rights-of-way are exempted from E zone regulations because the regulations apply to newer above or below ground utilities that are not in public rights-of-way.

Commissioner Blumenauer said he would like a matrix developed detailing the implications of moving ahead. He said he does not want to catch people in the crossfire between the City's environmental protections and its commitment to public health.

Ms. Feldman agreed to do that by next week, although she said it would be impossible to amend the Code between now and next week because of public notification requirements. She said she would report back on what could be done within existing regulations.

Charles A. Fagin, 2525 SW Montgomery Drive, objected to inclusion in the LID. He said they have been on the SW Montgomery sewer for 12 years after their branch was destroyed by landslides. He said they would be assessed over \$36,000 for their share, much of it on a lot that is inaccessible and unbuildable. He also objected to the damage heavy equipment would cause to his property as well as its potential to cause additional landslides. He said he believes everyone could pump up to an existing system.

Doug Bamarito, 2585 SW Montgomery, cited a neighbor who has been pumping up for 30 years and is now being assessed over \$8,000 for a sewer she will not physically be a part of. He contended that the present system is on City, not private, property. He said property owners have been paying quarterly sewer bills for many years but now they are being asked to pay far more than residents in Mid-County or Royal Woodlands. He said neighbors believe no one is really taking charge of the problem and asked Council to appoint someone to come up with a concrete plan so that this matter is resolved.

Commissioner Blumenauer asked Ms. Nolan to manage this matter and coordinate with other bureaus.

Joanne Kahn, 2811 SW Upper Drive, said they are not in the LID but sewage is collecting in the back of their property which makes it unusable. She asked Council to do something soon so this project will make the summer construction schedule and expressed hope that assessments could be capped.

Steve Winn, 2575 SW Montgomery Dr., said this issue surfaced in 1987 and commended BES for trying to unwind something that is a mess in every way. He said they are very frustrated to hear that the environmental review process may push construction of this sewer into next year. He said he is not happy with the amount of his assessment but believes building the sewer is now the single most important thing we can do.

Elizabeth Boylston, 2845 SW Upper Drive, asked that the City take more financial responsibility for the project.

Commissioner Blumenauer said Ms. Nolan will coordinate these issues with relevant City bureaus. He also asked the bureau to respond next week to questions raised regarding the financing as well as the legal ambiguities raised about ownership and the genesis of this project. He asked that this be scheduled at a Time Certain.

The Clerk asked if Council wished to overrule the remonstrances today and pass this to a second reading.

Harry Auerbach, Deputy City Attorney, said if Council votes to overrule the remonstrances and this ordinance is then amended next week, another second reading will be necessary.

Commissioner Blumenauer said there may be circumstances that justify adding an emergency clause.

Mr. Auerbach said he did not see any reason why an emergency clause could not be added next week.

Commissioner Blumenauer suggested overruling the remonstrances and passing this to a Second Reading, leaving open to Council the addition of an emergency clause to allow final adjustments in the ordinance.

Commissioner Kafoury so moved and Commissioner Bogle seconded. The motion carried. (Y-4)

Disposition: Remonstrances overruled and passed to Second Reading June 17, 1992 at 3 p.m. Time Certain.
