1322 Pledge \$68,000 to support operational costs of Salvation Army as Recovery Inn (Resolution)

Discussion: Commissioner Kafoury said Council has long realized how complicated a process finding shelter for the homeless is. She said generally the feeling is that mass shelters should be phased out but no solution has been found for dispersing the population. Trying to site smaller facilities in neighborhoods has caused a lot of problems too. She said the City has made general fund contributions to shelters in the past, although not to Recovery Inn. Commissioner Kafoury said this is meant to be a one-time only expenditure until a longterm shelter strategy is developed but, in the meantime, the City cannot afford to enter the winter with one half of its shelter capacity lost.

John Simmons, Salvation Army, said Recovery Inn not only provides shelter but offers a jobs program and other services for the homeless. He said they want to be good neighbors and believe it does no one any good to have the neighborhood deteriorate. He said they have worked aggressively to upgrade the facility and to prevent loitering. He added that a number of steps are underway to improve the entire shelter system and that this contribution will allow them to continue operating for another year.

Commissioner Kafoury said contributions have also been pledged from private parties and other government entities.

Al Jasper, 19 NW 5th, said he has observed not just homeless people but also drug dealers and illegal aliens. He suggested that all applicants be screened according to the same Immigration Service regulations imposed on businesses to determine their status as citizens or legal residents.

Chuck Currie, Burnside Advocates, said the shelter does deny service to anyone identified by Police as a drug dealer. Anyone involved in the jobs program must provide identification to indicate their legal status.

Greg Wentworth, Wentworth Chevrolet, said he is adamantly opposed to mass shelters as a way of dealing with the homeless problem. He said he has heard for a long time that the shelter will be getting better and better but over and over it has not. He said no one can run a mass dormitory shelter of this type successfully and urged that it be closed for 90 days to see what happens.

Roseanne Lee, 1814 SE 59th, member of the East Precinct Citizens Advisory Council, criticized the screening process for drugs at Recovery Inn and objected to the proposed contribution from the City.

Margaret Moreland, 811 E. Burnside, questioned the section in the resolution which states that the community is in the midst of important discussions about the future design of the homeless shelter system and it is critical that Recovery Inn play a role in this. She said such an assumption should not be made, noting that the Metropolitan Community Action Plan called for phasing out mass dormitory shelters by January, 1991. She criticized the current system, which puts inebriates, the criminally inclined and mentally ill together with no case management and said a stable source of funding should be found to improve the whole delivery system.

Commissioner Kafoury said the City agrees that mass shelters should be phased out but the facts are that attempts to site other programs have been extremely time consuming. She said the Salvation Army is not committing to long term operation and now is not the time to close up half our mass shelter spaces.

Major Neil Hogan, Salvation Army, said they are seeking an opportunity for an additional year's work to develop a shelter system. He said their position has always been that there be no drugs in the facility and staff is adamantly working to prevent loitering. He said it is better to work out details of a new system before closing out the current system, as reopening a facility will be much more difficult and have a greater impact on the community once it is closed and the difficulties flow back onto the streets.

Commissioner Bogle asked what special practices are in place to substantiate the statement that there are no drugs in the facility.

Major Hogan said they have a random process of room assignment to break up structures as well as regular staff observation, barring of known drug dealers from the facility, access to a drug-sniffing dog

Commissioner Bogle asked about searching for drugs.

He said they do not feel that legally they can do that.

Commissioner Bogle asked why screening for drugs would be different from screening for weapons as many clubs do. He questioned why a consent search for drugs could not be a condition for admittance.

Major Hogan said they visually observe but do not physically search people He said they believe their control measures have been successful.

Commissioner Bogle asked for amplification regarding breaking up the structure.

Major Hogan said staff would break up buddies when it comes to room assignments.

Commissioner Kafoury said this resolution does not actually allocate the money and committed to finding a way to more aggressively check for drugs before the allocation is approved.

Commissioner Bogle said when it comes down to actual allocation of funds there should be a stronger admittance program to eliminate drug users.

Regarding admittance procedures, Ms. Moreland said the majority of West Coast shelters do ask for i.d. but Recovery Inn does not. She recommended that such a program be adopted.

Mayor Clark said he is proud of Portland's homeless program but believes it is time to move towards transitional housing instead of mass shelters. He said he will vote for this but, before he votes to actually allocate the money, he would like to have a plan calling of closure of the facility by a specific date.

Commissioner Bogle agreed with Mayor Clark and said he also expects to hear from the Salvation Army about what it plans to do to tighten up admittance procedures to eliminate drugs in the facility.

Commissioner Kafoury said a longterm look is being taken at social service siting to make it is easier than it is now.
