2132 TIME CERTAIN: 9:30 AM - Establish criteria for City of Portland Sister Cities Relationships (Ordinance)

**Discussion:** Steve Orcutt, President, Portland Sister Cities Coalition, said the coalition was formed a year ago by representatives of the nine Portland's Sister Cities organizations. He said its goal is to provide mutual support and strengthen the City's international relationships.

Mayor Clark expressed strong support for the Sister Cities program, adding that it is important for Portland to connect with cities worldwide and be a part of the global economy.

**2160** Report on status of the 1992/93 Combined Charitable Campaign (Report)

**Discussion:** Art Alexander, Commissioner Lindberg's staffperson and Chair of the Charitable Campaign Committee, said the City raised \$111,331 this year, an increase over the \$92,000 raised last year. He named the organizations participating and thanked Phyllis Ray and all the bureau volunteers.

# \*2161 Amend Title 14, Public Peace, Safety and Morals to include a Chronic Nuisance Property Chapter (Second Reading Agenda S-2131; amend Code Sections 14.110.010 through 14.110.090)

**Discussion:** Commissioner Blumenauer said public testimony was concluded last week after five presentations before Council and a number of meetings in the community. He said this is one more tool to help the Police and neighborhoods ensure that people cannot, through a pattern of harassment and intimidation, hold others hostage in their own homes. He said it will be in place for a limited period of time, a year-and-a-half, during which time it will be monitored to make sure it has the intended results. He noted that Commissioner Kafoury is at work on a proposal to deal with some commercial applications, such as adult businesses.

Regarding the incident at Kellogg Middle School and the school's proximity to an adult motel, Commissioner Blumenauer noted that the City is at work on an ordinance to deal with such by-the-hour operations. He asked that Council request a joint effort on the part of the Bureau of Buildings and Multnomah County Health Division to visit that particular establishment as there appears to be shortcomings there that could result in the suspension of operations.

Commissioner Bogle asked if they needed fire inspectors.

Commissioner Blumenauer said yes, the high level of activity seems to require a higher level of scrutiny.

Commissioner Blumenauer noted the addition of an emergency clause last year but said he hoped there would be instructions to the Police to phase the start-up.

Commissioner Kafoury said one of the problems is that the City cannot target adult establishments although many believe criminal activity is significantly higher near such places.

Mayor Clark said this is a very good tool for community policing and will help the neighborhoods solve some problems they have been unable to touch before now.

She said the visual preference survey is an exciting technique to help determine what a street would look like with higher density.

**Discussion:** Commissioner Kafoury said this will allow for a public information campaign and involves partnerships with Metro, Washington and Clackamas Counties as well as City bureaus. She said it was clear from the

Albina Plan that people are confused about what higher density means and these programs should help the community accept the fact that there will be growth and focus on how it can be managed and controlled.

Mayor Clark said he is very much in favor of this, noting use of the visual survey technique in Copenhagen.

Commissioner Blumenauer said this will be folded into the Regional Rail Summit. He said he is pleased that the other partners in the region are kicking in some money.
