- Do NOT let yourself be baited by Commissioners or by the other side. Some Commissioners like to ask if you think renaming will turn the street into a ghetto. The only correct answer is NO.
- Be prepared for a long hearing. Council has scheduled 4 hours for the hearing and it may go longer.

- Food and drink are not allowed in Council chambers, but you can eat in the hallway outside. If you want more than water, you should bring it with you.

Because of a prior meeting commitment I will be unable to attend the council meeting this evening. Please accept this testimony in my absence (name & address at the end).

All of his adult life Cesar Chavez witnessed first-hand the harsh, unfair and degrading way huge corporate farms and growers treated their migrant laborers. He had always been taught to treat other people fairly and with respect, and to be non-violent in his struggles. He spent his adult life working to obtain fair working and living conditions for all farm laborers, and to end racial and economic discrimination in both rural and urban areas. He is credited with achieving dignity, respect, fair benefits, safer working conditions and humane living conditions for hundreds of thousands of farmworkers.

Having read Attachment A to the proposed Ordinance, some of the arguments on both sides are more emotional than substantive. In recent weeks I've reviewed multiple biographies on Cesar Chavez which document the fact that he does deserve to be honored in some way. Renaming a street, however, **DIS**honors him and all he stood for. Special interest groups (mainly CECBC) and big corporations (in this case the city government), are taking away the dignity and respect of the "laborers" --- the businesses and residents living along 39th Avenue --- causing financial hardship and disrupting business operations that doesn't just affect them, but has a ripple effect all across the country and anywhere else where their addresses are in mailing lists and systems that will have to be changed with related expense by those list-holders. More than 12 years ago a local genealogical library moved, and moved again 5 years later. Despite dozens of requests there are, to this day, some lists that still show the original address.

Don Hanson pointed out Portland's growth and the need to honor more recent

historical figures. His point is valid, but it should not be done by erasing previous figures from history or renaming existing streets. Rather than revise current guidelines to make street renaming easier, consideration should be given to establishing a list of street names to be used when new streets are constructed, to avoid the hardship and ill-will created by the renaming process. Unless the city is willing (and able) to underwrite the cost to everyone involved, including loss of revenue caused by the change, it should not mandate renaming an established street.

In the Metro section of the May 31, 2009 Oregonian, Paul Chavez talked of his father's achievements and questions that renaming a street would further the causes his father had devoted his life to. The fact that CECBC has worked for two years to rename a street shows their tunnel vision and lack of understanding of what Cesar Chavez truly stood for. Maybe they need to rethink the "challenge" they are advocating, and quit acting like the arrogant, discriminating corporations Chavez fought all his life.

There is a local school for homeless children, many of them children of migrant workers. What a fitting honor it would be to name this school for him, and establish scholarships in his name for the graduates to further their education --- something Cesar was unable to do.

THAT is the way to make history and to further his causes. Or, how about renaming the nearly-completed Saturday Market with it's organic produce and wonderful crafts and, often, fiesta atmosphere. Not as good an idea as a school, but would definitely honor the man and fulfill everything Don Hanson advocated in his letter.

The fact that a street CAN be renamed, doesn't mean that it should be !!!

To the Mayor and City Commissioners,

My name is Janet Baker and I've lived on NE 39th for twenty years. It is the first and only home I've owned. I thank my lucky stars that I landed on 39th Avenue because there is an incredibly strong sense of community on this street. When I moved here it was a mix of newcomers like me and people like my next door neighbors, an elderly couple who had lived in their house for more than fifty years. Over the years most of these older folks, including my next door neighbors, have died but their memories stay with those of us still living on the street. When my next door neighbor's niece from Eugene calls me, one of her first questions always is, "What is happening these days on 39th?" So for me and my neighbors, the name NE 39th does indeed have a history, almost a family history. What right do you have to take our neighborhood history and neighborhood name from us?

Note that I said I live on 39th Avenue; I didn't say I live in Beaumont-Wilshire. In the hearing before the "Historian Panel" and recorded in their report, is this comment. "People speak of living in neighborhoods such as Belmont, Hawthorne, Hollywood, Woodstock, and Laurelhurst. No one talks about living on 39th Avenue. It does not define a neighborhood or community." I don't think the person making that comment understands the history and sense of community on this street and I don't think the Historian Panel does either.

I think the problems with understanding the importance of 39th stems in part from the criteria used by the Historian Panel committee which were very biased against streets with numerical names. Obviously a numbered street cannot be "named after a prominent person" which

was the first characteristic they considered. Obviously a numbered street cannot "commemorate an event or concept whose importance is equivalent to that of a prominent person", their second criteria. So a numbered street starts off with handicap in this process, making it more likely to get selected for renaming.

The postcard survey of homeowners, renters and business owners along NE 39th Avenue registered a strong NO to the idea of renaming the street. Somehow the voice of folks most impacted by renaming seems to have gotten lost in the discussion. In my twenty years of living on NE 39th, I've paid over \$50,000 in property taxes and yet I feel like my postcard vote and the vote of others on this street don't carry any weight. In fact we feel like our vote counts less than the 16 year olds that were allowed to sign the street renaming petition, another aspect of the renaming procedure that I object to.

We all make policies and procedures in our jobs and even with our families. Sometimes we make the rules up, apply them and find out things that sounded logical on paper fall apart when we try to implement them. It happens all the time. Sometimes it's embarrassing that you didn't see the logic flaws in the rules you designed but the best managers can admit these mistakes.

Commission Fritz acknowledged flaws in the street renaming procedures in her written response to me. She said, "After this application has been approved or rejected, I will ask my colleagues to revise or suspend the street renaming process in the City Code. The applicants have followed the Code in this case, and should be commended for doing so. I believe we can do better with the process, as we consider how Portland should grow and change in the 21st century. Requests to honor heroes and heroines should bring communities together, rather than dividing us. "

She acknowledges what we have been saying on 39th Avenue -- that this process doesn't work as intended.

It would be easy for you to just ignore these problems and vote yes on

the renaming and figure you can fix the problems on the next round, as Commission Fritz suggest. But why make the people living on 39th and running businesses on 39th live with the consequences of a decision based on a bad process? Do the right thing, the hard thing. Vote against the renaming.

Dear Commissioners and Mayor:

As a resident of Laurelhurst, I have studied the arguments for renaming 39th Ave as Cesar Chavez Blvd., and have come to the conclusion that renaming 39th Ave. is not the best course of action for the city. My decision is based on the following:

1. Costly- The renaming of a street creates many costs that are incurred by individuals, small businesses, the City of Portland, the State of Oregon, and the tax payers of Portland and Oregon. We have heard costs from the city of at least \$100,000 for street signs alone, with costs from other impacted entities sure to raise this figure much higher.

The people that are in favor of the street renaming have not demonstrated a value-add to the city. We know that a street renaming will cost at least 6-figures but what is the quantitative gain of renaming the city? The proponents of such a renaming should demonstrate that there is a quantitative gain.

Further, there is no way to demonstrate any other type of positive gains (such as qualitative gains) that the City of Portland would incur. With such a financial framework ignored by the renaming supporters, fiscal issues- particularly in a bad economy- should take precedence. Tax payer monies, small business monies and city monies can be better spent for important public services that are badly underfunded and in jeopardy.

2. Divisive- The will of the people should not be ignored and in fact must be paramount to elected officials. Based on the city survey of residents and homeowners on 39th Ave., it appears the vast majority of these parties are against this renaming. The statistical information released by the City of Portland shows 87.7% of survey respondents opposed the renaming.

Further, several neighborhood associations also oppose this renaming. As a resident who attended one of these neighborhood meetings, I can tell you that we took our stance after a long discussion and a democratic vote of residents of the neighborhood. At the Laurelhurst Neighborhood Association meeting there were zero votes in favor of the renaming. With such strong opposition to this renaming, it is a logical conclusion that renaming the street for Cesar Chavez will only create more division in the city over this issue. I am sure this is not what the City of Portland is looking to foster.

3. Illogical- The proponents of renaming a numbered street that transverse a large part of the city have not demonstrated why the renaming makes logical sense. Not only does 39th Ave. have a long history in various Portland neighborhoods but it also has a long history as part of the numbered grid system that many Portland residents

- and visitors- use as a marking post for travel and direction. Starting to dismantle this logical and useful street system creates confusion and is completely illogical to the navigational benefit this system creates.

4. Disruptive- This change will be disruptive to the large number of businesses and homes located on 39th Ave., as well as creating confusion to those that have to travel or interact with these same entities. As a former resident of San Francisco I saw the renaming process in action. San Francisco chose to rename Army Street in honor of Cesar Chavez, but the renaming was done to a street that was largely industrial and not populated with hundreds of homes and small businesses that would be impacted by a change. Portland's 39th Ave. does not fit that formula, which kept disruption to a minimum in San Francisco.

In fairness, I have also listened to and read the arguments by the group advocating for a street renaming.

What I have heard leads me to the conclusion that their arguments for renaming are based on pure emotion. Decisions based on emotions are usually regrettable.

Making 39th Avenue a sacrificial lamb for the renaming process is not a wise move for the City of Portland or for those businesses, residences or travelers that will be impacted by a renaming. The perceived inflexibility of those that want to rename 39th avenue should not be a model that the City Council follows.

I am hoping that the City of Portland shows creative leadership and real wisdom by naming a new bridge, building or other edifice for Cesar Chavez which would bring greater understand and less tension among races and create a place that all people of Portland could support.

Dear Commissioner:

I live and have a business between Grand and SE 39th street. I own a duplex on SE 39th. I am against renaming SE 39th Street but have no problems with renaming Grand Street.

When I moved to Portland in 1992, I had a friend who had lived here for a couple of years. I was amazed by how she could give me directions to any place I wanted to go, without consulting a map. She sat me down with a map and explained how the city was laid out and I had few problems after that getting around, despite being direction and right/left challenged. This was because there is a rhyme and reason to the way the streets line up. Every exception to that makes it more confusing. The numbered streets--especially the major ones are an important part of that street grid.

Numbers are even more important than the way the streets generally follow an alphabetical order within pockets. I can't quite put my finger on the psychological security of numbered streets that run in order. Perhaps part of it is that it allows you to count how many blocks you have walked or how far away something is. Perhaps it is because we learn the order of numbers very early in life. Perhaps it is because there are mnemonics using numbers. For instance, 39= 3x3 and 3 goes into 9 three times.

I travel 39th all the time. I have a duplex on 39th street--when I have to have workers go there, they can find it easily because 39th tells them where it is--unlike Chavez.

I want to stress, I have no problem with naming a street for this important labor organizer--I wish it could have happened while he was alive. I have no problem naming such a street in my neighborhood. I have no problem telling his story. I think it would be cool to have his name on a street that crosses a bridge and goes into downtown Portland.

I DO have a problem with changing the name of 39th street. I see it as the first step in permitting future such changes and believe that each one that does not fit with logical rules of order (alphabetical or numeral) will make our town much less visitor friendly and navigable.

There's a community garden going in for food for people of the community that seems more fitting and ideal to what he was about and famous for, or the new Pedestrian Bridge, if built, that hasn't been named yet. Neither idea would cost people and business for changing their name.

It seems the activists just want change no matter who it affects. It takes away from the "Honor the Person" you should get in naming something after them, when it is being crammed down your throats.

We'd ask that you listen to the people directly involved and think a little about "majority ruling" for once and the expense.

Commissioner Fritz. Thank you for your response. I understand that the process was followed by the petitioners (it is, frankly, not that difficult of a process for petitioners to follow), but if you take a look at the process you'll see that it is flawed in a number of ways.

1. 2,500 signatures from other than the abutting property owners can dictate to, not only the vast majority of Portlanders, but to the neighborhoods affected. If you dig a little into the signature gathering, you'll notice that the petitioners struggled to get 2,500 signatures. They submitted two batches, the second of which was significantly flawed. The Code allowed residents as young as 16 to sign the petition. 16 year olds can't vote in state or federal elections, but they can decide what the street in my neighborhood is named? How can this be at all in line with representative democratic principles?
2. The Chavez Committee has been asked numerous times to meet with the affected neighborhoods to discuss alternatives and has refused. They won't show up to meetings. They won't listen to other ideas. This is not how Portland works. Portland has a vast system of neighborhood associations that you have championed, and yet none of them has been listened to. The Committee's refusal to meet with the neighborhoods shows a callous disregard for the views of the people who will be actually impacted by this street change. While there is lots of criticism of the people who oppose this change, what does it say that the people who want it won't sit down eye to eye with the people they are impacting and explain their reasoning. Portland believes in process and frank and honest communication. This process has been everything but that. It appears that the Chavez Committee doesn't think that they need to meet with the impacted neighborhoods because they think they have this vote locked up at City Hall and that it doesn't matter what the people actually impacted think. I hope they are wrong.
3. There are numerous arguments about the application of the Code to this particular process. Who signed the petition? What is a legal resident of Portland? Have 2,500 signatures been gathered to rename one street or three? Was there one application or three submitted, in violation of the Code? Isn't 39th Ave. "significant in its own right?" The Historical Review Panel thought it was. Does 39th Ave. terminate in Portland or Milwaukie? Ultimately, those are all easily dispensed with by the Council or the City Attorney. But each question that is raised, shows how dysfunctional the process is, and emphasizes how fixed it feels to the people along and near 39th Ave. No matter how much you want to talk about the process, the process is arbitrary.
4. Our elected officials should listen to the vast majority of their constituents when matters, such as this, don't deal with fundamental civil rights or equality. I don't feel that elected officials check their independent judgment at the door when elected, or have to take a poll for every expenditure of money. But when you have such a majority opposed to a plan not involving basic rights, and 88% of abutting property owners opposed, their voices should be given the greatest weight.

Ultimately, I ask you whether renaming 39th Ave. is "in the best interest of the City." I don't think it is. It creates a divide. It creates distrust of local government. It is not a serious issue that should be undertaken in these tough times. Dave Lister's editorial in today's Oregonian (Link unavailable) sums up how a lot of people in the City feel. You've shown courage on the Lents Park issue. Do the same here. Enough is enough.

There are a number of other great ways to name something in Mr. Chavez's honor (a park, a bridge, etc.) that would accomplish all of the good things that he stood for, and that Portland stands for. Renaming 39th or any other street is not the way. Chavez's own family has recognized that he would not want this shoved down people's throats. Other leaders in the Oregon Hispanic community have similarly recognized that this process has been terrible and the conduct of the Chavez Committee inexcusable and wholly inconsistent with what Chavez stood for. While I think renaming should be done very rarely, it can be done successfully (Rosa Parks comes to mind). But, when the renaming is so opposed by the people who have to live with it, it doesn't make any sense and is not in the best interest of the City.

Thank you for your message. I have not yet decided how I will vote on the proposed renaming. Your views are helping to inform my choices for the hearing on June 23 at 6 p.m. in City Hall. I would like to see respect for both those asking for the change, and those opposing it. The citizens making the request are given the right to do so in the Code, and a street renaming process is required in State law. Even in tough times, I believe it is important to honor the rules that apply to everyone, and to apply them as adopted. Others have been free to request the other names you suggest for honoring. The folks making this request have done the work and followed the process. It seems unreasonable that state law specifies a street renaming process, then many people demand that it not be used. The statute specifies that the Planning Commission makes a recommendation, then the elected officials vote, rather than a vote of the people or the affected property owners and residents determining the outcome.

I do recognize that many residents and businesses on and near 39th Avenue are strongly opposed, and that will weigh into my decision. My responsibility is to honor the laws of Oregon and the City of Portland, and to consider the long term public good.

After this application has been approved or rejected, I will ask my colleagues to revise or suspend the street renaming process in the City Code. The applicants have followed the Code in this case, and should be commended for doing so. I believe we can do better with the process, as we consider how Portland should grow and change in the 21st century. Requests to honor heroes and heroines should bring communities together, rather than dividing us.

Hello. I live on Hazelfern Pl., just west of NE 39th Avenue. I am writing to express my strong opposition to the street renaming effort, especially as it pertains to NE 39th Avenue. I've summarized the basis of my opposition below:

Opposition as to 39th In Particular: One of the reasons that the East side is easy to drive around and accessible to residents and visitors alike is its numbered grid. Taking a numbered street that is as central to the inner east side as 39th and turning it into a named street will cause unnecessary confusion. While it seems like a little issue for people who don't live here, it is a big inconvenience for those of us that have been telling people where we live by referencing NE 39th for years or decades. We will lose all ability to do that if we now have to refer to Cesar Chavez street which no one will recognize or have any idea where it is. There is no precedent for renaming a numbered street like this. If we are to create new precedent, then we should do so for a figure that has some relationship to Portland (see more below on this issue).

Opposition to Renaming Any Street After Chavez: While I respect Mr. Chavez for what he accomplished, I respect hundreds of historic figures for what they have accomplished. But, that respect does not need to be demonstrated in the inconvenience and expense associated with renaming a street. What about Susan B. Anthony and numerous other leaders of the women's movement? What about our own Barbara Roberts? Harvey Milk? Where does it end? It is an unnecessary inconvenience and expense and we can't go around renaming streets constantly to appease various minority groups. Naming a new public park or other building is more than sufficient. How about the big new park at SoWA? Naming that park after Mr. Chavez will not disrupt the lives of ordinary Portlanders nor cause expense to businesses.

Most importantly, while he accomplished great things, Mr. Chavez has no connection whatsoever to this City. Taking the name of a historic street that serves as a point of reference and meaning to hundreds of thousands of Portlanders to honor a man who had nothing to do with this City is disrespectful of the people who actually live here, and through their tax dollars, energy and dedication have made this city the great place that it is.

This is a classic example of setting up a process to justify making significant changes demanded by a group that will not be affected by the economic results.

It is sad to see the Council capitulate to the demands of a group who clearly don't understand why Caesar Chavez would have declined the "honor."
