ORDINANCE No. 183216

*Amend contract with LNS Court Reporting and Captioning for closed captioning services for City Council sessions (Ordinance; amend Contract No. 35532)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On September 29, 2004, the City Council passed Ordinance No. 178779 authorizing a contract with LNS Court Reporting & Captioning to provide closed captioning of Council meetings for a period of five years.
- 2. Portland City Council meetings are open to the public, providing access to public decision-making and allowing participation in City Government. City Council meetings are cable-cast live on City Net 30, Portland Community Media television.
- 3. LNS has consistently provided excellent service that is timely, of high quality and invaluable to members of our community. LNS is a local company and is a Women Business Enterprise certified by the State of Oregon.
- 4. In addition to the captioning services, LNS provides a transcript of the Council meetings which is incorporated into the official City Council minutes.
- 5. Auditor's Office is exploring new ways to produce our City Council agenda as well as the official minutes. In the meantime there is a need for consistency and continuity in providing closed captioning services.
- 6. This ordinance waives City Charter 2-105(a)(3) which limits contracts to five years and authorizes an amendment to the contract to extend the expiration date to September 30, 2010 with the option to renew in one year increments for a period not to exceed 5 years.
- 7. Auditor's Office has sufficient funds to cover this expenditure in its 2009-2010 fiscal year budget.

NOW, THEREFORE, THE Council directs:

- a. The Auditor is authorized to execute, on behalf of the City, an amendment substantially similar in form to that attached as Exhibit A to extend the expiration date to September 30, 2010 in the amount of \$36,000 with LNS Court Reporting & Captioning to provide closed captioning of City Council meetings.
- b. The Purchasing Agent is authorized to execute future amendments extending the contract in one year increments for a period not to exceed five years for an amount of \$36,000 per year.

c. The Mayor and Auditor are authorized to draw and deliver checks in payment of obligations under this contract.

Section 2. The Council declares that an emergency exists because of the need to provide hearing impaired citizens with access to City Council meetings: therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
