ORDINANCE No. 183415

* Waive bond requirement of Code Section 5.08.160 D to allow the Bureau of Fire and Police Disability and Retirement to make final benefit payments not exceeding \$10,000 to heirs or next of kin living outside of the State of Oregon. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Code Section 5.08.160 sets forth the procedures for delivery of checks payable to deceased persons. Subsection D of that Section provides that before a check may be delivered to an heir or next of kin who lives out of state, the heir or next of kin must sign a hold harmless agreement and post a bond to defend and indemnify the City, its officers, agents and employees against any claim, suit, action or judgment arising out of the delivery or payment of the checks.
- 2. The Bureau of Fire and Police Disability and Retirement (FPDR) handles several member deaths each month. If the deceased member has no surviving spouse or dependent minor children, the decedent's final benefit is issued to his or her heir or next of kin. An overwhelming number of the decedents' heirs or next of kin live out of the State of Oregon.
- 3. For final benefit payments not exceeding \$10,000, it is desirable to deliver the final benefit check to the heirs or next of kin without the time and expense involved in obtaining a bond.

NOW, THEREFORE, the Council directs:

a. The requirement of Portland City Code Section 5.08.160 D for a bond shall be waived for claims by the heirs or next of kin of FPDR deceased members for benefits not exceeding \$10,000.

Section 2. The Council declares that an emergency exists because undue delay would interfere with efficient execution of the distribution of the final benefits due to decedents' families; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
