FINDINGS OF FACT AND CONCLUSIONS OF LAW:

A document entitled Notice of Compliance (Exhibit 46) was received from the Bureau of Development Services ("BDS"). Exhibits 46, 46a, and 46b are admitted into the evidentiary record. This decision is based upon all of the exhibits admitted into the evidentiary record.

BDS requests the Hearings Officer to: (1) waive two \$500 civil penalties (paragraph 5 of the Hearings Officer's Order dated December 12, 2008) and (2) close the Hearings Office file/case.

The Hearings Officer finds it reasonable and appropriate to grant the two BDS requests.

ORDER AND DETERMINATION:

- 1. The \$500 monthly civil penalties (per paragraph 5 of the Hearings Officer's Order dated December 12, 2008) for the months of September and October 2009 shall be waived, lien numbers 148579 and 148746, and the monthly civil penalties for the months of November 2009 through July 2010 shall not be assessed.
- 2. This order has been mailed to the parties on January 15, 2010, and shall become final and effective on January 29, 2010. Any objections to this order must be in writing and received by

the Code Hearings Office prior to the effective date. This case will be closed effective January 29, 2010.

This order may be appealed to a court of competent jurisdiction pursuant to ORS 34.010 et seq.
