## **ORDINANCE No.** 183463

\*Approve settlement of claims with Thomas/Wright, Inc., EBAA Iron, Inc., and HD Supply Water Works Group, Inc., fka U.S. Filter Distribution Group, Inc. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In December 2007, the City of Portland, Bureau of Environmental Services ("BES"), filed a lawsuit against Ken Leahy Construction, Inc., and Thomas/Wright, Inc., in Multnomah County Circuit Court, entitled *City of Portland v. Ken Leahy Construction, Inc., and Thomas/Wright, Inc.*, Case No. 0712-14686, asserting claims for breach of the contract and for negligence. In turn, Ken Leahy Construction filed third-party claims against EBAA and HD Supply.
- 2. TWI, EBAA and HD Supply have agreed to settle with BES as shown in the attached Exhibit 1 (Settlement Agreement with TWI) and Exhibit 2 (Settlement Agreement with EBAA and HD Supply). The City Attorney's office and BES recommend approval of this settlement by City Council.
- 3. The City Attorney is authorized to prosecute and continue the lawsuit against the remaining parties and take all legal action necessary. Any settlement with other parties will come before Council for approval.

NOW, THEREFORE, the Council directs:

a. The Director of BES is authorized to execute the Settlement Agreement with Thomas/Wright, Inc., EBAA Iron, Inc., and HD Supply Water Works Group, in substantially similar form to that attached as Exhibits 1 and 2 to this Ordinance. Funds received pursuant to this ordinance shall be placed in BES's account.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
