

ORDINANCE NO. 183474

* Amend subrecipient contract with Transition Projects Inc. to add \$20,000 for outreach, emergency shelter, transitional shelter, permanent housing placement assistance, and other supportive services to assist homeless adults (Ordinance; amend Contract No. 32000093)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City of Portland passed Ordinance No 183048 authorizing Subrecipient Contract No. 32000093 with Transitional Projects Inc. (TPI) to provide outreach, emergency shelter, transitional shelter, permanent housing placement and other supportive services to homeless adults.
2. The above stated programs and services meet the goals and objectives of the Portland Housing Bureau (PHB).
3. Funding in the amount of \$20,000 in City General Funds will be added to this contract for a total not to exceed \$2,809,487 through the allocation of existing appropriations in PHB's FY 2009-10 Ending Homelessness Initiative budget.
4. The additional funds will be used to cover utilities and operational costs associated with the management of the Adult Winter Warming Center to provide expanded shelter to 90 homeless adults from November 1, 2009 to March 31, 2010.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Works and the City Auditor are hereby authorized to amend Subrecipient Contract No.32000093 with TPI in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2009-10 budget when demand is presented and approved by the proper authority.


SECTION 2. The Council declares that an emergency exists because delay in funding would interrupt TPI's ability to provide winter shelter services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
