

ORDINANCE No. **183492**

\* Authorize an Intergovernmental Agreement with the State of Oregon Police for the use of the Office of National Drug Control Policy and the National High Intensity Drug Trafficking Area Program grant funds (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Oregon Department of Justice was awarded \$3,000,000 by the Office of National Drug Control Policy's High Intensity Drug Trafficking Area (HIDTA) Program to support initiatives designed to implement the strategy proposed by the Executive Board of the Oregon HIDTA Program and approved by the Office of National Drug Control Policy (ONDCP) for Fiscal Year 2009.
2. The Oregon Department of Justice and the Oregon HIDTA Program awarded \$80,000 in funding to the Portland Police Bureau for efforts in disrupting and dismantling drug trafficking organizations in Multnomah, Washington, and Clackamas Counties by employing a multi-agency approach to significantly impact drug availability in the area.
3. The purpose of the agreement is for the City to reimburse the Oregon State Police for labor, operating equipment and supplies, and travel costs for work performed on cases submitted as part of the HIDTA grant administered by the Portland Police Bureau Drugs and Vice Division.
4. The City will, with ONDCP HIDTA grant funds, reimburse the Oregon State Police for the cost of all approved program expenses, not to exceed \$38,860.
5. The grant period is January 1, 2009, through December 31, 2010.

NOW, THEREFORE, the Council directs:

- a. The Mayor and City Auditor are hereby authorized to enter into an agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
