ORDINANCE No. 183620

*Authorize an Intergovernmental Agreement in the form of a grant not to exceed \$7,500 to the Social Equity and Opportunity Forum of Portland State University College of Urban and Public Affairs (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Planning and Sustainability promotes the City's goals to build a prosperous, equitable and environmentally healthy community through partnerships, by fostering innovation, and by inspiring and engaging residents, businesses, public institutions, and nonprofit agencies.
- 2. Portland State University's Social Equity and Opportunity Forum is conducting cutting edge research, teaching and engagement focused on integrated environmental, social and economic sustainability across city, county and regional levels.
- 3. The Social Equity and Opportunity Forum's work will have direct and immediate benefits for the citizens of Portland in the form improved understanding about the social dimensions of sustainability, interconnections with economic and environmental sustainability; and the ways and means to achieve and measure these outcomes.
- 4. The Social Equity and Opportunity Forum's work has been grant funded by several foundations with matching commitments from public and private community partners.
- 5. Integrated sustainability is an essential part of our future as a community and the City through the Bureau of Planning and Sustainability is an indispensable partner in this work.

NOW, THEREFORE, the Council directs:

a. The Mayor and Auditor are authorized and directed to execute an intergovernmental agreement with Portland State University substantially in conformance to the agreement attached as Exhibit A for the purposes described in Section1 above, for an amount up to \$7,500.
