

ORDINANCE No. 183629

* Amend subrecipient contract with Portland Development Commission to add \$525,509 for the coordination of the Economic Opportunity Initiative programs. (Ordinance; amend Contract No. 30000702)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City of Portland passed Ordinance No. 182942 on June 24, 2009 authorizing Subrecipient Contract No. 30000702 with Portland Development Commission (PDC) for the transfer of the Economic Opportunity Initiative programs.
2. The City of Portland/Portland Housing Bureau desires to amend Subrecipient Contract No. 30000702 with PDC to add \$525,509 for a total contract amount not to exceed \$5,843,674. Funds are carryover funds from FY 08-09. Following are the additional amounts and their funding sources:

Funding Sources	Amounts
Northwest Health Foundation	\$16,500
One-Time-Only General Fund	\$69,942
Northwest Area Foundation	\$184,000
CDBG (Formula)	\$255,067
Total	\$525,509

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Works and the City Auditor are hereby authorized to amend Subrecipient Contract No. 30000702 with PDC for the coordination of the Economic Opportunity Initiative programs in accordance with the Amendment No. 1 attached as Exhibit A (attached to original ordinance only).
- b. The Mayor and City Auditor are hereby authorized to draw and deliver warrants chargeable to the FY 2009-10 Budget when demand is presented and approved by the proper authority.


