## ORDINANCE No. 183926

\*Amend Intergovernmental Agreement with TriMet for design and construction management services for the I-205 Light Rail Project (Ordinance, amend Contract No. 53100)

The City of Portland ordains:

Section 1. The Council finds:

- In June 2008, by Ordinance No. 181955, the City Council authorized a Design and Construction Management Services Agreement (Agreement) between the Tri-County Metropolitan Transportation District of Oregon (TriMet) and the City of Portland (City) for the I-205 Light Rail Project (Project).
- 2. Construction is complete, and the Project opened for passenger service in September 2009. The Project is in the final phase of close-out.
- 3. The Agreement must now be amended to extend the term and add additional staff services related to Project close-out.
- 4. All other terms and conditions of the Agreement remain unchanged.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge and the Auditor are authorized to execute, on behalf of the City, Amendment No. 1 to the Design and Construction Services Agreement with TriMet, substantially in accordance with the amendment attached to the original of this Ordinance and, by reference, made a part hereof.

Section 2. The Council declares that an emergency exists because the Agreement expires on June 30, 2010 and must be extended to reflect final tasks related to the Project; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
