

An Ordinance adopting the report of the Viewers in the matter of the proposed

opening, widening, laying out and establishing of East Fifth Street from the south line of East Stark Street, to the north line of East Clay Street

making an assessment of the benefits and damages set forth in said report and directing an entry of such assessment in the Docket of City Liens.

The City of Portland does ordain as follows :

SECTION I.

WHEREAS, The Common Council, deeming it expedient to open, *widen* lay out and establish *an extension of East Fifth Street* in the City of Portland ~~Street~~ *from the south line of East Stark Street to the north line of East Clay Street by widening the street ten feet on each side; said East Fifth Street to be eighty feet wide and the side lines to be forty feet distant from and parallel with the present center line thereof*

did, on the *7th* day of *September* 1892, direct the City

Surveyor to survey the same, and to mark the boundaries thereof, and to make a plat of such survey, and a written report containing a full and perfect description of such proposed

Street and the boundaries thereof and of the portion of each lot, tract, or part of either, to be appropriated for such street, and the City Surveyor having made

such survey, plat and report and filed said plat and report in the office of the Auditor

and Clerk on the *14th* day of *September* 1892 and the same being satisfactory to the Common Council was adopted by Ordinance No. *7861* entitled :

and afterwards on the 5th day of October 1892 by resolution,

viewers of the said proposed

opening, widening, laying out, and establishing
of East Fifth Street,

to meet at the office of the Auditor and Clerk on the 24th day of

October

1892 at 10 o'clock in the forenoon of said day for the

purpose of viewing said proposed street and making an assessment of the benefits and

damages occasioned by such proposed opening, widening, laying out,

and establishing of East Fifth Street of which

due notice was given in the manner provided by law by publication of notice in the

"Portland Daily Dispatch"

a newspaper of general circulation

published in the City of Portland, as will more fully appear by the proof thereof duly

presented and filed in the office of the Auditor and Clerk, and said Viewers having met

for the purpose of making said view and assessment at the time and place appointed and

on that and subsequent days to which they adjourned, not exceeding one week, having

made such view and assessment of benefits and damages, and the same being satisfactory

to the Common Council ;

Now, therefore, The report of

the following is a copy, to-wit :

TO THE HONORABLE, THE COMMON COUNCIL,
OF THE CITY OF PORTLAND, OREGON.

GENTLEMEN:-

The undersigned, appointed Viewers, in the matter of the proposed widening of East Fifth (5) street, East Portland in the City of Portland, from the south side of East Stark street to the north side line of East Clay street, by widening the street ten (10) feet on each side, said street to be eighty (80) feet wide and the side lines to be forty (40) feet distant from and parallel with the present center line of said East Fifth street, by resolution adopted at your regular meeting of October 5th 1892.

Would respectfully report that in pursuance of individual notice to ourselves by the City Auditor and Clerk, we met on the 24th day of October, 1892, at ten (10) o'clock A.M. at the office of said City Auditor and Clerk, when after being duly sworn, as viewers aforesaid, to faithfully discharge the duties assigned us, we were furnished with a copy of the Surveyor's Report of Survey, with plat and description of such lots or fractions of lots or parcels of land, proposed to be appropriated to public use for said proposed widening of East Fifth street as described, and adopted by Ordinance Number 7681.

We also received the respective claims of Geo. C. Sears, H. Shogren, J. B. Parker and E. Heintz, per O. E. Heintz, Agent.

We thereupon adjourned to meet on the 27th, day of October 1892, at ten (10) o'clock A.M. at which time we proceeded to view the proposed widening of East Fifth (5) street, through the whole length thereof, and the grounds, lots or parcel of

lots, and the improvements on, along and adjacent to said proposed widening of East Fifth street, and on that and subsequent days, to which we adjourned, not exceeding one week, we determined, found and assessed the damages that will be sustained, by the taking of property, and the benefits that will be derived by all parties respectively, on account of said proposed widening of East Fifth street, aforesaid to be as is herein particularly described and set forth, taking into consideration and making allowance for the claims of the parties hereinbefore mentioned.

We find that in order to widen said street to the width of eighty (80) feet it will require off the land of J.B. Parker a parcel of land described as all of the west ten (10) feet of lot one (1), block 122, East Portland, in the City of Portland, containing five hundred (500) square feet.
