All Ordinances to provide for the location of the streets

North East Park Street from the north line of "A" Street to the south line of "M" Street except a strip twenty feet wide off of the east side thereof north of the south line of "C" Street.

North West Park Street from the north line of "A" Street to the south line of "M" Street except a strip twenty feet wide off of the west side thereof south of the south line of "C" Street.

"D" Street from the east line of "G" Street to the west line of "H" Street along the east line of "H" Street from the west line of "G" Street.

"C" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet east of the west line of North East Park Street.

"L" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

Whereas upon the 5 day of May 1872 a petition was filed with the Mayor and Council of the City of Portland praying for the creation of the hereinafter named streets and the addition of the City of Portland to wit: -

North East Park Street from the north line of "A" Street to the south line of "M" Street except a strip twenty feet off of the west side thereof south of the south line of "C" Street.

"D" Street from the east line of "G" Street to the west line of "H" Street along the east line of "H" Street from the west line of "G" Street.

"C" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

"L" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street, - which said petition set forth the particulars concerning the same, and a detailed description of the property to be vacated and the names of the persons to be particularly affected therein and was duly signed by the parties interested therein.

And whereas the Mayor was given of the Council of said City and that at a regular meeting of the Council of said City of Portland upon the 20th day of June 1872, a resolution was made by said Council for an Ordinance of said Council declaring said portions of said streets to wit: -

North East Park Street from the north line of "A" Street to the south line of "M" Street except a strip twenty feet wide off of the east side thereof north of the south line of "C" Street.

North West Park Street from the north line of "A" Street to the south line of "M" Street except a strip twenty feet wide off of the west side thereof south of the south line of "C" Street.

"D" Street from the east line of "G" Street to the west line of "H" Street along the east line of "H" Street from the west line of "G" Street.

"C" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

On Ordinance to provide for the vacation of that portion of

North East Park Street from the north line of K Street to the south line of M Street except a strip twenty feet wide off of the west side thereof north of the south line of H Street.

North West Park Street from the north line of K Street to the south line of M Street except a strip off of the west side thereof north of the south line of H Street.

D Street from the east line of Eighth Street to the west line of Seventh Street

E Street from the east line of Eighth Street to the west line of Seventh Street

H Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

I Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

Whereupon this 5th day of May 1882 application was filed with the City Clerk, reading the Charter of the City of Berkeley praying for the vacation of the hereinafter named streets in accordance with the City Charter.

North East Park Street from the north line of K Street to the south line of M Street except a strip twenty feet wide off of the west side thereof north of the south line of H Street.

North West Park Street from the north line of K Street to the south line of M Street except a strip twenty feet wide off of the west side thereof north of the south line of H Street.

D Street from the east line of Eighth Street to the west line of Seventh Street

E Street from the east line of Eighth Street to the west line of Seventh Street

H Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

"L" Street from a point twenty feet east of the east line of North
West Park Street to a point twenty feet west of the east line
of North East Park Street, which said petition set forth the
particular circumstances of the case, gave a distinct description of
the property to be vacated and the names of the persons to be par-
ticularly affected thereby and was duly signed by the parties
interested therein. And

Whereas, said petition was given to the Presidency of said pe-
tition and that at a regular meeting of the Municipal Council
of said City of Portland upon the second day of June 1882,
said petition was read & made by said petitioners for an
order of said Council declaring said por-
tions of said streets to be

1. From East Park Street from the north line of "A" Street to the south
line of "M" Street except a strip twenty feet wide off of the east
side thereof north of the south line of "K" Street.

2. From West Park Street from the north line of "H" Street to the
south line of "M" Street except a strip twenty feet wide off of the
west side thereof north of the south line of "K" Street.

3. From the north side line of Eighth Street to the north line of Seventh Street

4. From the south side line of Eighth Street to the west line of Seventh Street

"K" Street from a point twenty feet east of the west line of North

West Park Street to a point twenty feet west of the east line of North East Park Street.

"L" Street from a point twenty feet east of the east line of West Park Street to a point twenty feet west of the east line of North East Park Street, vacated, which said notice was duly published in the daily "Oregonian" and weekly "Oregonian" public newspapers printed and published in said City, for seven days prior to said seventh day of June.

And upon this seventh day of June 1882, at a regular meeting of said Common Council it appearing that the consent of all persons owning property immediately adjoining said portions of said streets ought to be vacated had been duly obtained through a writing and acknowledgment as required by law, and it further appearing that the said portions of said streets had never been opened or improved and that it would be for the best interests of all parties concerned to have said portions of said streets vacated and that no injury would be caused thereby to any person interested therein or to the said City or to the public generally and it further appearing that no objection has been made or filed thereto and no one has appeared and objected, -

The City of Portland does ordain as follows: That all the following enumerated portions of the following enumerated streets in Conch's addition to the City of Portland be vacated: -
North East Park Street from the west line of "K" Street to the south line of "M" Street except a strip twenty feet wide off of the east side of the north of the south line of "K" Street.

North West Park Street from the north line of "K" Street to the south line of "L" Street except a strip twenty feet wide off of the east side of the north of the south line of "K" Street.

"I" Street from the east line of Eighth Street to the west line of Ninth Street.
"K" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street.

"L" Street from a point twenty feet east of the west line of North West Park Street to a point twenty feet west of the east line of North East Park Street, and all the sections are hereby vacated.
