Ordinance No 18147

An Ordinance to vacate all of that part of T Street, sometimes known as East Twelfth Street, between Linn Avenue and Ochoco Avenue in Sellwood, now within the corporate limits of the City of Portland.

WHEREAS, due notice was given by advertisement thereof by Portland Railway, Light and Power Company in the official newspaper of the City of Portland in the County of Multnomah, State of Oregon, to-wit: the Portland Daily Abstract, that at a regular meeting of the Council of said City to be held on Wednesday, the tenth day of June, 1908 (being the time stated in said notice or advertisement) a petition would be presented to said Council by said Portland Railway, Light and Power Company, praying for the vacation of all that part of T Street, sometimes known as East Twelfth Street, between Linn Avenue and Ochoco Avenue in Sellwood, now within the corporate limits of the City of Portland, and due proof of the publication of said advertisement or notice has been duly filed with the Auditor of said City and is now on file with said Auditor, and said advertisement or notice is in all respects as provided by the Charter of said City of Portland; and,

WHEREAS, said petition was duly presented to said Council on the day named in said notice and above set forth, and said petition duly sets forth a description of all of said part of said T Street, sometimes known as East Twelfth Street, sought to be vacated and the purpose for which all of said part of said T Street, sometimes known as East Twelfth Street, was sought to be vacated, is proposed to be used, and the reason for such vacation, and to which petition there was appended as a part thereof, and as a basis for such vacation and for the granting of the prayer of said petition, the written consent of the owners in fee simple of more than two-thirds of the real estate fronting on said part of said T Street, sometimes known as East Twelfth Street, sought to be vacated, said frontage being computed as is provided in the Charter of said City of Portland, and which said written consent was duly acknowledged by said owners as provided by said Charter, and said petition with said consent attached thereto was duly filed with the Auditor of said City of Portland, and is now on file with said Auditor, and said petition is in all respects as provided by the Charter of said City of Portland; and

WHEREAS, the said Council of said City of Portland upon said presentation of said petition and the filing of the proof of due publication of said notice or advertisement did (on said tenth day of June, 1908) duly fix the time for hearing said petition and objections thereto, if any be filed, as and to be at the regular meeting of the Council of said City, to be held on 22nd day of July, 1908, in all respects as provided by said Charter; and,

WHEREAS, at the said time fixed by the Council for hearing said petition and objections filed thereto, if any, the Council did ascertain and determine that the consent of the requisite number of front feet had been obtained, as provided by the Charter of said City, for the vacation of said part of said T Street, sometimes known as East Twelfth Street, as aforesaid, and made such finding a matter of record, and upon such hearing of said petition the Council found that the public

interest would not be prejudiced by the vacation of all said part of said T Street sometimes known as East Twelfth Street, and that the consent of the owner and owners of the requisite number of front feet had been obtained for the vacation of all of said part of said T Street, sometimes known as East Twelfth Street, as provided by said Charter, and that said Council grant the prayer of said petition in whole and vacate all said part of said T Street, sometimes known as East Twelfth Street, as sought to be vacated by said petition, and duly caused said vacation to be made a matter of record and does hereby cause the same to be made a matter of record; and,

WHEREAS, no objections have been made or filed to said petition or to the vacation of all of said part of said T Street, sometimes known as East Twelfth Street, as prayed for in said petition, or otherwise; Now, Therefore,

The City of Portland does ordain as follows:

Section 1: That all of said part of said T Street, sometimes known as East Twelfth Street, between Linn Avenue and Ochoco Avenue in Sellwood, now within the corporate limits of the City of Portland, be and the same is hereby vacated.
