

ORDINANCE No. 184068

Authorize an Intergovernmental Agreement with East Multnomah Soil & Water Conservation District to provide laboratory analytical services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The goal of this Intergovernmental Agreement is to provide laboratory analytical services for East Multnomah Soil and Water Conservation District (EMSWCD) by the City of Portland and;
2. The purpose of this agreement is to detail the responsibilities, compensation, and services to be provided by each party.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to execute an Intergovernmental Agreement with EMSWCD for the purpose described in Section 1.
- b. The Director of the Bureau of Environmental Services is authorized to execute amendments to this agreement to extend the term or increase the agreement amount.
- c. The Mayor and Auditor are hereby authorized to accept approximately \$10,000 per year for revenues in the Bureau of Environmental Services Sewer Operating Fund from EMSWCD for the City of Portland providing laboratory analytical services.
